## RELATING TO THE APPOINTMENT OF CARL ADOLPHO III TO THE MOLOKAI PLANNING COMMISSION

WHEREAS, by correspondence dated October 19, 2017, Acting Mayor Keith A. Regan notified the Council he nominated Carl Adolpho III to the Molokai Planning Commission for a term expiring on March 31, 2021, to fill a vacancy replacing Michael Drew, pursuant to Section 2.28.020, Maui County Code, and Sections 8-8.4 and 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and

- 2. That the Council expresses its gratitude and appreciation to Carl Adolpho III for his willingness to be considered for public service and actively participate in County government; and
