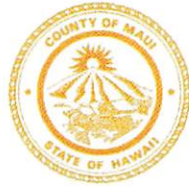

**SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2026, APPENDIX B, DEPARTMENT OF FINANCE, GENERAL FUND AND DEPARTMENT OF FINANCE, SPECIAL REVENUE/TRUST AND AGENCY FUND, OUTRIGGER DUKE KAHANAMOKU FOUNDATION, COMMEMORATIVE LICENSE PLATE)**

On behalf of the Department of Finance, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2026 APPENDIX B, DEPARTMENT OF FINANCE, GENERAL FUND, SALES OF SPECIAL LICENSE PLATES: SPECIAL LICENSE PLATES, DEPARTMENT OF FINANCE, SPECIAL REVENUE/TRUST AND AGENCY FUND, OUTRIGGER DUKE KAHANAMOKU FOUNDATION COMMEMORATIVE LICENSE PLATES."

The purpose of the proposed bill is to amend the Fiscal Year 2026 Budget to amend Appendix B, Revenues – Fees, Rates, Assessments and Taxes, Department of Finance, General Fund, to add new categories entitled "Outrigger Duke Kahanamoku Foundation Commemorative License Plates," following Polynesian Voyaging Society Commemorative License Plates, and to amend the



Department of Finance, Special Revenue/Trust and Agency Fund, to add new categories entitled "Outrigger Duke Kahanamoku Foundation Commemorative License Plates," following Polynesian Voyaging Society Commemorative License Plates.

Hawai'i Revised Statutes 249-9.8 authorizes the creation and issuance of a special license plate commemorating Duke Kahanamoku and his contributions to Hawai'i with proceeds benefiting the Outrigger Duke Kahanamoku Foundation. The Honolulu Department of Customer Services has notified the County of Maui that they anticipate the plates being ready for distribution around February of 2026.
