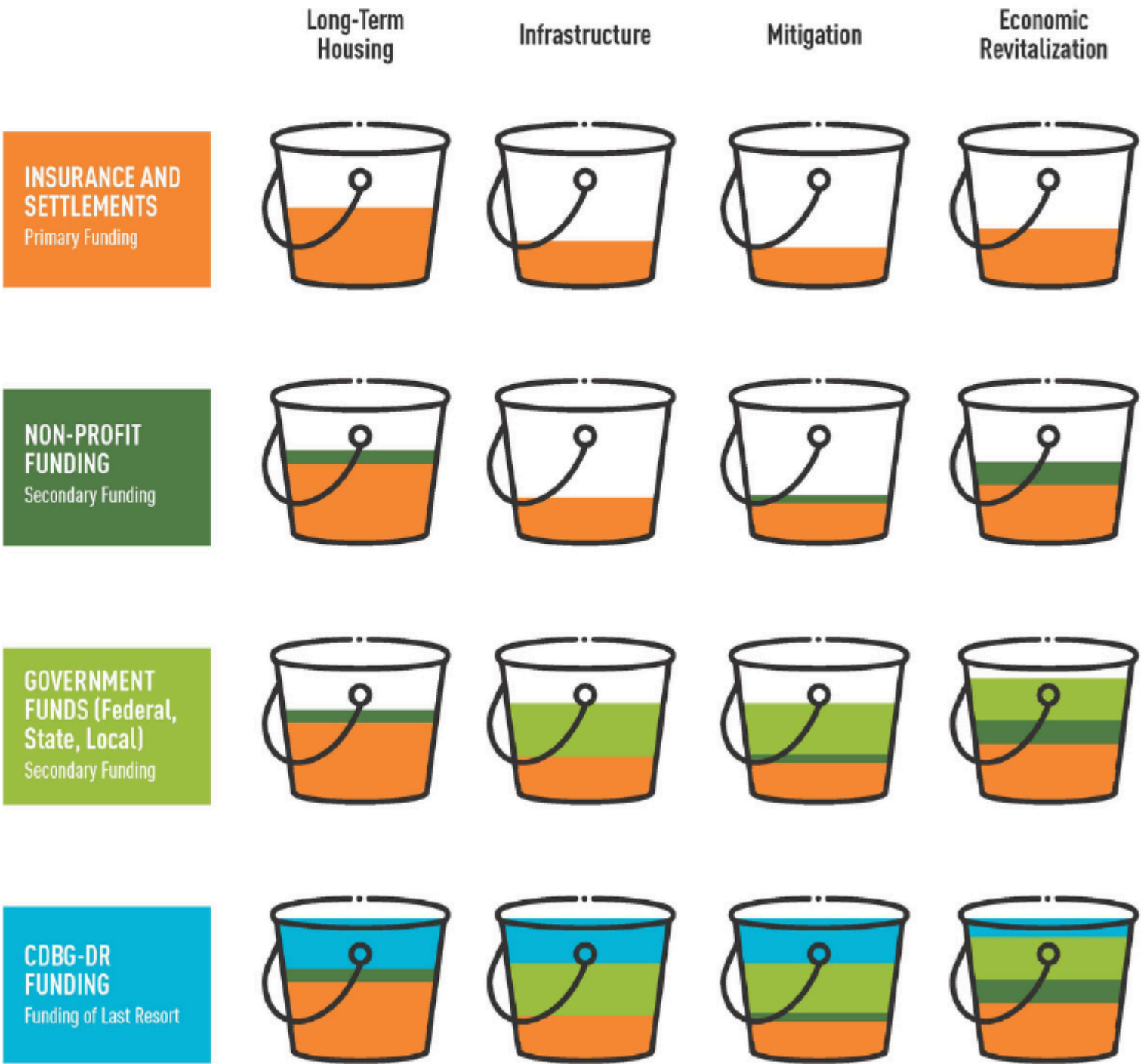




DISASTER-RELATED NEEDS AND POTENTIAL FUNDING SOURCES

INTEGRATING CDBG-DR FUNDS WITH OTHER FUNDING SOURCES



Maui’s continued recovery will be funded through multiple sources, including insurance payouts, settlements, support through non-profit organizations, and government support.

EXAMPLE: NEW WELLS AND STORAGE TANKS IN WEST MAUI



Project: Develop up to five groundwater wells and add storage tanks to replace surface water supplies, mitigate against future drought & wildfire, and supply water for new housing.

Total project cost: \$128 Million



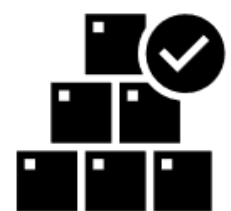
Total number of housing units supported:

- Hardens water supplies for 2,500 units
- Creates new water supplies for 3,300 units



Funding Eligibility:

- FEMA Public Assistance: Not eligible, not damaged in wildfire (\$0)
- EPA SRF: All four wells eligible (\$128 Million)
- FEMA HMGP: Only two wells & tank eligible (\$86 Million)



Funding Request Status:

- Submitted to HMGP in Jan 2025, on hold by HIEMA
- Included on EPA’s SRF Disaster Supplemental funding list in December 2025, awaiting EPA determination
- Included as “unmet need” in CDBG-DR action plan

WHAT CAN CDBG-DR FUND?

“...necessary expenses related to disaster relief, longterm recovery, restoration of infrastructure and housing, economic revitalization, and mitigation...”



Housing

Activities that lead to restoring and improving the housing stock



Infrastructure

To replace, rebuild and provide new infrastructure



Mitigation

Must align with other federal agencies that provide funds specifically for mitigation and resilience



Public Services

Address job losses, impacts to tax revenues, and impacts to business. Economic revitalization and workforce development and health and wellness services for kupuna

CDBG-DR FUNDS CANNOT BE USED FOR THE FOLLOWING PURPOSES:

- Activities that are unrelated to the disaster
- Replacing other federal funding sources
- Activities that are ineligible under CDBG regulations



WHAT IS A CHOICE LIMITING ACTION?

A choice-limiting action refers to any activity in which a grantee commits or expends funds that reduce or eliminate their opportunity to choose alternatives for a project, particularly those related to environmental impacts or the quality of the human environment.

The County must submit a plan to HUD for the CDBG-DR funds that does not prematurely identify potential subrecipients or allocate funds without adhering to the required procurement processes.
