Chair and Members:

Your Water Authority, Social Services, and Parks Committee, having met on February 25, 2025, makes reference to Resolution 25-50, entitled "APPROVING THE APPOINTMENT OF JONATHAN LIKEKE SCHEUER TO THE EAST MAUI REGIONAL COMMUNITY BOARD."

Resolution 25-50's purpose is to approve the appointment of Jonathan Likeke Scheuer to the East Maui Regional Community Board as the Hawaiian Homes Commission's representative for a term expiring March 31, 2030.

Your Committee notes that the Council approved Jonathan Likeke Scheuer to the East Maui Regional Community Board as the Hawaiian Homes Commission's representative for a two-year term that expires on March 31, 2025 (Resolution 23-179).

Your Committee notes that the East Maui Regional Community Board was established after an amendment to the Revised Charter of the County of Maui (1983), as amended, was approved by voters in the November 2022 General Election.

Your Committee notes that Charter Section 8-19.2 requires one member of the East Maui Regional Community Board be a representative of the Hawaiian Homes Commission and recommended by the Department of Hawaiian Home Lands.

Your Committee further notes that under Section 2.60.040, Maui County Code, only County residents are eligible for an appointment to a

board, commission, or committee, unless the Council waives the residency requirement by a resolution adopted by a two-thirds vote.

By correspondence dated January 27, 2025, the Chairman of the Hawaiian Homes Commission informed the Chair of your Committee that DHHL voted and unanimously approved Jonathan Likeke Scheuer as the representative on the East Maui Regional Community Board.

A representative of DHHL outlined steps in the selection process to fill the Hawaiian Homes Commission representative's seat:

- DHHL hosted a virtual meeting on October 28, 2024, to consult with beneficiaries.
- Approximately 3,063 postcards were sent to lessees and applicants living in the County, along with emails to 50 homestead leaders to advertise the meeting.
- Following the meeting, DHHL provided beneficiaries 30 days to submit their desired qualities for the representative.
- The following recruitment process was approved by the Hawaiian Homes Commission at its December 17, 2024, meeting:
 - 1. The East Maui Regional Community Board vacancy and application form were posted on DHHL's website. Homestead leaders were notified by email.
 - 2. The application deadline was January 13, 2025.
 - 3. DHHL staff reviewed applications and selected a potential nominee using the following guidelines:
 - a. DHHL affiliation; and

- b. Relevant water experience and knowledge related to the water license areas of the East Maui Regional Community Board, including:
 - i. Firsthand experience with ranching, farming, aquaculture, or loko i'a;
 - ii. Water resource management and watershed restoration experience;
 - iii. Advocacy related to water; and
 - iv. Completion of the I Mana i ka Wai: Kūkulu Kahuwai Water Law and Leadership training series.
- 4. DHHL staff submitted their recommendation of Jonathan Likeke Scheuer to the Hawaiian Homes Commission.
- 5. At its meeting of January 21, 2025, the Hawaiian Homes Commission voted to unanimously approve Jonathan Likeke Scheuer as its designated representative.

Your Committee interviewed Dr. Scheuer. Dr. Scheuer spoke to the Board's efforts over the last few years, including:

- Setting up the East Maui Water Authority as established in the Charter, including appointing its director and organizing the East Maui Regional Community Board's operations.
- Successfully advocating for the State Department of Land and Natural Resources to pause their proposed disposition of a

water license covering the diversion of public surface water from Koʻolau Forest Reserve.

• Participating in preliminary discussions with Mayor Bissen and East Maui water license holders to develop a cooperative approach with State DLNR.

Dr. Scheuer acknowledged that there is a lot more work before the East Maui Regional Community Board. As the former Board Chair, he said he was honored to work with a group committed to finding solutions for Maui County's people.

Your Committee expressed concern that Dr. Scheuer did not reside in the County. Nonetheless, based on his expertise and the endorsement of the Hawaiian Homes Commission and the Department of Hawaiian Home Lands, your Committee expressed support for Dr. Scheuer's appointment and thanked him for his willingness to serve.

Your Committee voted 6-2 to recommend adoption of Resolution 25-50. Committee Chair Sinenci and members Cook, Kama, Paltin, Rawlins-Fernandez, and U'u-Hodgins voted "aye." Committee members Lee and Sugimura voted "no." Vice-Chair Johnson was excused.

Your Committee is in receipt of Resolution 25-50, CD1, approved as to form and legality by the Department of the Corporation Counsel, incorporating nonsubstantive revisions.

Your Water Authority, Social Services, and Parks Committee RECOMMENDS that Resolution 25-50, CD1, attached, entitled "APPROVING THE APPOINTMENT OF JONATHAN LIKEKE SCHEUER TO THE EAST MAUI REGIONAL COMMUNITY BOARD," be ADOPTED.

WHEREAS, Section 8-19.2(1) of the Revised Charter of the County of Maui (1983), as amended, requires one member of the East Maui Regional Community Board to be a representative of the Hawaiian Homes Commission, recommended by the Department of Hawaiian Home Lands, and approved by the Council; and

WHEREAS, on the East Maui Regional Community Board, Jonathan Likeke Scheuer's two-year term as the Hawaiian Homes Commission's representative expires on March 31, 2025; and

WHEREAS, by correspondence dated January 27, 2025, attached as Exhibit "A," the Chairman of the Hawaiian Homes Commission advised that the Department of Hawaiian Home Lands approved Jonathan Likeke Scheuer to be reappointed as the representative on the East Maui Regional Community Board; and

WHEREAS, Jonathan Likeke Scheuer is not a resident of the County of Maui; and

WHEREAS, Section 2.60.040, Maui County Code, requires that the appointment of a non-county resident must be approved by a resolution approved by a two-thirds vote; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

- 1. That, under Charter Section 8-19.2(1) and Code Section 2.60.040, it approves the appointment of Jonathan Likeke Scheuer to the East Maui Regional Community Board as the Hawaiian Homes Commission's representative for a term starting April 1, 2025, and expiring March 31, 2030; and
