Pursuant to your correspondence dated January 3, 2024, the following are responses to your questions.

1. Please explain the basis for recognizing the East Maui Water Authority as a separate department from the Office of the Mayor. Under this rationale, if other water authorities are created, would they also be recognized as separate departments?

Response: The Administration reviewed the Council discussions related to the Charter amendment for the East Maui Water Authority ("EMWA") as well as documentation submitted to the Salary Commission and the salary set for the Director. It was determined that in order for the EMWA to operate as "an independent County of Maui agency responsible for the acquisition and management of the State of Hawaii water licenses for the collection and delivery system and any other systems acquired in the region" (memo from Councilmember Sinenci to the Salary Commission dated August 8, 2023), it should exist as a separate Department. As the EMWA was the only entity established in the Charter amendment, that was the name used for the Department. If additional water authorities are created in the future, the

Administration will determine if they should be independent departments or exist under the current water authority department.

2a. Please provide the position titles for the 3.0 equivalent personnel and indicate whether the positions are appointed or civil service.

Response: The positions are as follows:

- Director not civil service
- Administrative Assistant II civil service, SR-20C, BU3
- Grant Coordinator civil service, SR-24H, BU13
- 2b. Further, has the Salary Commission established the salary for the Director of the East Maui Water Authority? If so, what is the salary?

Response: Yes, the salary commission established the salary for the Director at \$149,000.

3. Please explain why no funding is being transferred for Category B -Operations & Equipment.

Response: While \$20,000 in funding was included in the Fiscal Year ("FY") 2024 Budget for Category B – Operations & Equipment for the EMWA, no expenditures have been made as personnel have not been hired. Funding for the three positions was included for ten months in the FY 2024 Budget which will not be fully expended. If funding is needed for Operations or Equipment in the current FY, the Administration will submit a resolution requesting to move the funds under the EMWA from Category A to Category B. Should additional funding be necessary, the \$20,000 will be reallocated from Office of the Mayor. If these funds are not needed by the EMWA, they will not be expended by the Office of the Mayor.
