Thank you for your letter of April 10, 2017 requesting information related to the abovereferenced subject. Please accept our apologies for the delay in responding. The Department of Water Supply is transmitting for your review and offers the following responses to your questions:

Question:

1. Provide an overview/summary identifying size, length, square footage/acreage of lot dedication. (This information may be on the attached map, but to prevent misinterpreting the data a summary would be helpful).

Answer: The dedication is not a lot dedication, but an easement dedication. The map shows the easement square footage as 10,381 SQ. FT.

2. Identify the rationale, specific subdivision or County condition, if any, that is requiring acquisition of the road widening lot dedication.

Answer: Please note that the easement is not for road widening lot dedication. The easement dedication is required due to the construction of a new 12-inch water main extension with valves, a new ARV with manhole, and a new fire hydrant to serve the West Maui Village Project (multi-family apartments).

Question:

- 3. Specify details of the subdivision or related development the dedication will serve.
- Answer: The easement dedication is related to the West Maui Village Project (multi-family apartments). Based on the building permit, the project proposed to construct propose 26 apartment buildings, housing 158 units.

Question:

- If County revenue was utilized for the acquisition, please indicate the amount.
- Answer: No County revenue was utilized for the acquisition.
- Question:
 - 5. Outline details of the easement such as: function of the easement; what improvements will be installed; provide infrastructure size and dimensions.
- Answer: The easement dedication is required to allow the County to maintain the waterline improvements. The improvements consist of approximately 154 lineal feet of new 12-inch water main extension with valves, a new fire hydrant, two new water service laterals and manholes for two new 3-inch water meters, a new 8-inch fire line lateral, and a new cleanout with manhole.
