AUTHORIZING SETTLEMENT OF FIRST FIRE AND CASUALTY INSURANCE OF HAWAII, INC. V. COUNTY OF MAUI, ET AL.;
CIVIL FILE 2CCV-24-0001055

WHEREAS, Plaintiff First Fire and Casualty Insurance of Hawaii, Inc. filed a Complaint on December 17, 2024, in the Second Circuit Court, State of Hawai'i, Civil File 2CCV-24-0001055 against the County of Maui alleging claims of negligence, respondeat superior, and vicarious liability regarding an incident that occured on December 19, 2022; and

WHEREAS, the County of Maui, to avoid incurring expenses and the uncertainty of a judicial determination of the parties' respective rights and liabilities, will attempt to reach a resolution of this case by way of a negotiated settlement or Offer of Judgment; and

WHEREAS, the Department of the Corporation Counsel has requested authority to settle this case under the terms presented in an executive meeting before the Government Relations, Ethics, and Transparency Committee; and

WHEREAS, having reviewed the facts and circumstances regarding this case and being advised of attempts to reach resolution by way of a negotiated settlement or Offer of Judgment by the Department of the Corporation Counsel, the Council wishes to authorize the settlement; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

- 1. That under Section 3.16.020, Maui County Code, it approves settlement of *First Fire and Casualty Insurance of Hawaii, Inc. v. County of Maui, et. al.*, Civil File 2CCV-24-0001055, under the terms discussed in an executive meeting before its Government Relations, Ethics, and Transparency Committee;
- 2. That it authorizes the Mayor to execute a Release and Settlement Agreement on behalf of the County in this case, under terms and conditions as may be imposed
