**SUBJECT: UTILITY POLE PLACEMENT APPROVALS PURSUANT TO
CHAPTER 12.16, UTILITY POLES, MAUI COUNTY CODE**

Section 12.16.010 (Placement - Council permission required; exceptions) of the Maui County Code (MCC) authorized the Director of Public Works to approve the installation of utility poles upon a public highway when the height of the new utility poles does not exceed the height of existing poles on the highway by more than five feet and the number of new poles does not exceed six.

The following annual report, called for in Section 12.16.010 MCC, summarizes the projects approved by the Director in calendar year 2017.
