

Overall Sentiment







I am providing e-comment testimony in support of funding for the Maui Soil and Water Conservation Districts (Maui SWCDs).

The four Maui Soil & Water Conservation Districts consists of Central Maui, Hana, Olinda-Kula, and West Maui. They are are legally constituted, self-governing units of the State of Hawaii, organized under Hawaii Soil & Water Conservation District Law, Chapter 180, Hawaii Revised Statutes. Their purpose is to address soil and water conservation issues within their respective boundaries on the islands of Maui and Kahoolawe.

The SWCD Directors are unpaid volunteers who consist of farmers, ranchers, land managers, and engineers. Most of the volunteer directors have been serving on their respective board for over 10 years.

Funding is needed to provide clerical and technical assistance for tracking projects and grants, personnel management, coordinating education outreach events, and providing assistance to agricultural producers, farmers, and ranchers, regarding natural resources concerns across Maui. The District's goals are to help increase conservation efforts for Maui landowners through the creation of conservation plans or by providing brief technical assistance. The Districts also work with government agencies, as well as community members, to complete watershed scale projects.

All of the programs involving SWCDs are community based. SWCD directors are residents from their respective districts and welcome community input toward identifying natural resource and public safety concerns. The SWCD Programs carry out activities in partnership with County, State, and Federal agencies.

The Districts voluntary board members cannot adequately provide enough time to initiate, implement, and support the entirety of the District's projects and programs, which is why funding is necessary to provide clerical and technical support for the four SWCDs.



Aloha Maui County Councilmembers,

My name is Casey Kamaunu and I am the head committee Chair of KKHS Project Grad Class of 2026.

I am testifying in STRONG SUPPORT of the Kekaulike High School Foundation's Upcountry Winter Festival 2026.

The festival includes a craft fair, holiday display, food trucks and booths, non-profit information booths, keiki games, and entertainment – not to mention that Santa and Mrs. Claus graced us with their presence!

Here are a few stats from 2024:

- 54 Small businesses/vendors from our Maui community participated
- 15 Kekaulike complex clubs and organizations participated from 4 of the 7 schools within the complex (66% increase from 2023)
- 60 Volunteers came from the Upcountry community to make this festival successful
- 8 Non-profit organizations provided information to festival goers on their mission and impact on the community
- 1,492 Attendees were counted (a 36% increase from 2023)

In addition to the event serving as the Kekaulike High School Foundation's main fundraiser, it also serves as a

fundraiser for complex clubs and organizations. This year, the 15 clubs and organizations that participated made well over \$7500 in sales to help fund their activities.

The Kekaulike High School Foundation aims to support the ENTIRE Kekaulike complex, through scholarships for students and grants for teachers. With this event's help, KHSF is on track to provide its own foundation scholarships to graduating seniors for the third consecutive year, with funds doubling from last year. This event also helped complex staff fund projects in areas ranging from elementary school robotics to high school science labs to multiple art classes to field trips to learn about our native bird species.

Due to this event being held for last couple of years our children have been able to raise about \$2500.00 towards their project grad night for next year. We absolutely love this event as it is very family and community based event. With so many options from food, games, craft fair vendors as well as no profit organizations and businesses it is truly a great event to attend as well as be apart of. Not to mention the holiday display along with the photo ops with Mr. & Mrs. Claus. We look forward to this event being able to be held each and every year.

If you look at how the assessors office has reassessed owner-occupied properties across Maui County, in particular using the assessors map for my own middle class neighborhood of Makawao Ranch Acres, you can see that the assessed values all climbed by 400k, some smaller properties by 300k. I've seen similar adjustments made in other areas.

With the mayors proposed budget using his proposed owner-occupied tax rate of \$1.70 on values up to \$1.3M, that would create a windfall for the country. In my own case (237 AUOLI DR) it would be a tax increase of approximately 60%. Similar tax increases exist for other people in my neighborhood.

- 1. I really don't understand why the assessors office decided to do this land value increase in one large increment. While the property values have gone up, the assessors office has not kept up with the inreased values. Are they attenpting to correct that with the 400k jump in land values which seems to be across the board?
- 2. Is it the mayor and council's intent to impose ~ 60% property tax increase on middle class owner-occupied properties?

I would recommend a further cut in the tax rates for owner-occupied properties with values less than \$1.5M, smaller increase for properties between \$1.5M and \$3M and perhaps no cut or a smaller cut in properties > \$3M.

BFED will need to work out the math here, I have not done that. My intent and hope is that the property taxes for owner occupied properties with values in the lowest tier see either no increase in tax or a small increase in tax for the next fiscal year. The lowest tier should be adjusted to \$1.5M. (The mayor proposed \$1.3M). Those increases

would not affect my property as the total assessment after exemptions is still under \$1M.

I also think that the assessors office owes us an explanation as to why they did the sudden increase in land values like they did. I'm sure they will point to expensive comps, but the assessors office in past years has increased land values in smaller increments. What changed this year? I think they owe us an answer.
