



2. As it relates to the Administration Program's Goal #1, item 2, explain how the Department increased its completion rate of administrative investigations within 90 days from FY 2024 to FY 2025. (Page 657, Program Budget) (TC)

*FY 2024 – 76.93 percent completion rate within 90 days*

*FY 2025 – 100 percent completion rate within 90 days*

*There is no hard reason why we were able to complete 100% of the investigations within the 90-day window. There are extenuating circumstances that dictate how fast an investigation can be completed. For instance, if the accused party is on leave or vacation, it will delay the process. Same for witnesses and the person responsible for submitting the investigation. Sometime, we need data from a company and that process can be delayed. It all depends on the circumstances.*

3. For the Administration Program's Goal #1, item 3, describe the Department's recruitment strategy. (Page 657, Program Budget) (TC)

*The Department's recruitment strategy focuses on innovative and comprehensive approaches to attract top talent while filling vacancies efficiently. The goal is to build trust, establish authentic connections, and ensure that recruitment efforts align with the needs of the community and the department. Key initiatives include:*

#### ***Career Fairs & Outreach Efforts***

- *The department attends career fairs both locally (across Maui and statewide) and nationally, with recent training efforts in Nevada.*
- *Collaborations with local colleges and universities across the state to promote awareness of law enforcement careers.*
- *Strengthening ties with the Honolulu Police Department's Recruitment Team for joint recruitment efforts.*
- *Engaging specialized units (such as Vice Narcotics, K9, SRT, Traffic, and Community Policing) to conduct interactive demonstrations at career fairs and school visits.*

#### ***Advertising & Media Campaigns***

- *Expanding outreach through radio advertisements by securing bids from all Maui radio stations.*
- *Leveraging social media platforms and digital ads alongside the launch of a new, interactive MPD recruitment website to make the application process easier and more user-friendly.*

#### ***Community & Educational Partnerships***

- *Working with the Department of Education's Career Pathway Counselors to introduce law enforcement careers to students.*
- *Continuing the Senior Project Law Enforcement Experience, where high school seniors can job shadow officers.*
- *Expanding the Citizens Police Academy to foster public awareness and engagement with the department.*

### ***Recruitment & Testing Support Programs***

- ***Test Prep Tuesdays:*** Offering tutoring and study sessions for the written exam.
- ***Workout Wednesdays:*** Providing physical agility training for applicants to help them pass the Physical Agility Test (PAT).
- ***Ride-Along Program:*** Allowing applicants to experience police work firsthand to keep their interest and commitment strong.

### ***Recruitment Center & Open House***

- *Opening MPD's first law enforcement recruitment center in a mall to directly engage with applicants.*
- *Collaborating with the Juvenile Crime Prevention Division (JCPD) to provide mentorship and outreach programs.*
- *Hosting Open House events to introduce the public to MPD career opportunities in a friendly, welcoming environment.*

### ***One-Stop Shop Hiring Events***

- *Hosting 3-4 events per year that streamline the hiring process for Police Officer 1 and Emergency Services Dispatcher positions. These events provide same-day testing, interviews, and application processing.*

### ***Housing Assistance for Applicants***

- *Providing recruits with affordable housing options through the Hale 'O Laie Housing Program, which offers fully furnished one-bedroom units at \$1,700/month (including utilities). This initiative is aimed at alleviating financial burdens and supporting retention.*

- *Assigning dedicated recruiters to focus exclusively on recruitment, allowing for more personalized engagement and enhanced outreach to potential candidates.*

*In this case, it was used to develop a communications strategy to improve and inform recruitment and retention efforts, support a trusting relationship between the Department and the community, and identifying top issues and pain points for community members*

*This was the intention post 2022 - but we didn't do it because of funding, then the fire.*

*Neighborhood Crime Watch is a program that is now called National Neighborhood Watch Program. This program also incorporates Business Watch.*

*The program is designed to empower community members to take an active role in their community and to work with neighbors as well as police to reduce crime in their neighborhoods and businesses. The program brings together Law Enforcement, private organizations/businesses and individual citizens in a nation-wide effort to reduce crime and bridge the gap. Crime prevention is at the forefront of how this program works. Teaching a proactive approach to crime and giving them the tools and resources to be successful in our efforts, is the goal. The newly established Neighborhood crime watch group is given real data/statistics for their neighborhood and given the standardized neighborhood crime watch presentation. Which gives them tips and tools on reporting and being the best witness that they can and where to report any issues. The neighborhood also receives visible crime prevention signs that are erected in their neighborhoods. These community members give meaning to the signs by taking a persistent approach to reporting crime in their area. It gives the community members the opportunity to work together and communicate with one another. They are also introduced to our Community Police Officers, who assist them going forward with any chronic issues they experience in their neighborhood.*

*The relevance of this program for neighborhoods as well as the department, is the goals of crime prevention and community mobilization. Uniting community members and law enforcement that share the same goals of living in a neighborhood that they feel safe in.*

***Citizens' on Patrol-***

Volunteer program in South Maui. Ambassadors of our department. Patrolling areas and educating communities as well as visitors and deter crime with their presence and report when necessary.

***Chaplaincy Program-*** for our MPD personnel and their families as well for our community and partnering agencies.

***L.E.A.D.- Law Enforcement Against Drugs.*** CRS teaches in elementary schools on Maui. Giving our keiki tools to navigate emotions, active listening skills, confidence communication, drug prevention, addressing Bullying in person and online as well as violence and consequences.

***E Ola... Saving lives-*** Partnering up w HIDTA to give free classes to the community and business to educate them about the fentanyl epidemic in our communities. The participants are given free Narcan and pouch for attending the class. We also sit on the Hawaii Opioid Initiative (HOI) board. To take an active role on fentanyl.

***Shop with a Cop*** activity in Decembers: Collaboration with the Children's Justice Center (CJC), Kiwanis, Walmart as well as our PSB.

This activity allows law enforcement to work on relationships with our keiki that sometimes view police in a negative light. For instance, arresting a parent or sometimes taking a child into protective custody. Whatever the reasons are, this our opportunity to bridge that gap. The officer takes the child shopping during the holidays.

We work closely to support and collaborate w/ our Public Safety Branches, such as DLNR, Sherriff's, National Parks as well as other community agencies.

### ***MMEU (Mobile Medical Educational Unit) Program***

*The MMEU program assists Maui's unsheltered community by providing a range of services designed to meet their immediate needs. These services include:*

- *Food stamps*
- *Non-critical wound care*
- *Health check-ups*
- *Mental health counseling*
- *Wellness assessments*
- *Financial services*
- *Animal care/check-ups*
- *Haircuts*

*Community Partners include:*

- *Aloha House*
- *Department of Education "Homeless Outreach for Unsheltered Youth"*
- *Goodwill Hawaii*
- *Maui Aids Foundation*
- *Maui Humane Society*
- *Project Vision*
- *Private practitioners and others.*

### ***LIYT (Live in Your Truth) Program***

*Project LIYT is a voluntary program aimed at Maui County youth ages 12-24, especially those who may be unsheltered, dealing with mental illness, substance use, or at-risk. The program's goal is to help these youth discover their potential by addressing:*

- ***Physical, emotional, spiritual, mental, social, and environmental health.***

*The program partners with various experienced facilitators and community resources to offer support to participants, guiding them to overcome challenges and discover their true potential.*

***EPIC (Emergency Preparedness Increasing Community Awareness)***

*EPIC is a community awareness presentation focused on Active Attacker situations, commonly known as Run-Hide-Fight protocols. The program helps participants:*

- *Prepare for potential active attacker incidents.*
- *Understand local statistics on firearms.*
- *Know what to expect when calling 911.*
- *Participate in reality-based drills and exercises.*
- *Test their organization's action plans, policies, and procedures for handling such emergencies.*

***CIT (Crisis Intervention Team)***

*The CIT program is a community-based initiative that improves how law enforcement and the community respond to individuals experiencing mental health crises. The program focuses on collaboration between law enforcement, mental health professionals, and advocates to provide specialized training and improve crisis response systems.*

- *MPD's CIT was launched in 2013 with over 250 certified members in Maui County.*
- *Maui is also the first county to offer CIT training to non-MPD employees.*

***Beautification***

*The CORE Unit's public health and safety initiative addresses community concerns on a weekly basis. This includes:*

- *Educating individuals about available resources, county ordinances, and Hawai'i State laws.*
- *Collaborating with other departments to remove discarded trash, paraphernalia, and abandoned vehicles.*

*The community benefits from all of these programs. In return we hope to see a more funneled approach to addressing issues and providing resources and answers, as well as the appropriate sections and agencies that can help them best. And really showing the support services side to the community. These programs work together to support the well-being of individuals, enhance community safety, and improve the overall quality of life for the residents of Maui.*

*This indicates that while the department exceeded its estimated goal for **FY 2024**, the target for the next two years (**FY 2025 and FY 2026**) is to conduct at least **12 community outreach activities** each year. The department is hopeful that, through continued efforts, it will **well exceed** this goal, continuing to make a positive impact within the community.*

MPD will always cover a beat by holding an officer back at work or scheduling another officer to cover the shift.*

As part of this initiative, a budget has been allocated to provide training and support aimed at enhancing the physical, mental, social, financial, and spiritual wellness of department personnel.*

*The department is proactively addressing employee wellness by engaging a certified psychologist to deliver specialized training and counseling services. These efforts are designed to equip law enforcement personnel with the necessary coping skills and tools to manage stress and improve overall well-being. Key components of this approach include:*

- ***Specialized Training and Counseling:*** *The psychologist will provide targeted training focused on mental health and wellness, including early recognition and intervention for at-risk employees.*
- ***Psychological Services:*** *Offering private and anonymous individual counseling sessions for personnel in need of additional support, ensuring that help is accessible in a confidential manner.*

*Within the first quarter of the subsidized vehicle program we have 29 participants. Approximately 40 employees have been approved so far, pending vehicle selection. Insurance only covers while officers are on duty, personal insurance covers when off-duty.*

*As required by the Charter, the Maui Police Commission receives and reviews all complaints from the public about officers and other personnel within the Maui Police Department. We do not handle internal complaints, those are done through Internal Affairs.*

*When the Maui Police Commission receives a complaint, it will be placed on the next meeting agenda to be considered during an executive session where the full Commission will determine whether an investigation should be done. Then the Commission will forward the complaint to the Investigator. If this funding is approved, the Investigator will be hired and will be an employee of the Maui Police Department but hired by and accountable to the Maui Police Commission.*

c. How will the Department resolve the complaints? (NUH)

*Upon completion of the investigation, a report is forwarded to the Maui Police Commission where it will be reviewed by the full Commission during its next meeting in executive session.*

*A determination is then made based on the findings contained within the report or the Commission can request additional information from the investigator. The decision is made during executive session and forwarded to the proper channels including all parties who are included in the investigation.*

6. As it relates to Computer Software, Index Code 910059B, will maintenance for CID and Cyber Crime units' software systems be a one-time expense or an annual one?(Page 20-21, Budget Details)(TP)

*These will all be annual cost; MDI is a system to manage unattended death cases, digital forensic systems for cybercrime operations.*

- *Drone/SUAs propellers, batteries and maintenance: \$300,000.00*
  - *Upkeep of our new drones with propellers for the proper and efficient operation to ensure no incidents*
  - *Batteries lifespan is approx. 100 cycles, due to climate battery gets swollen and becomes inoperable.*
- *Wall mounted television: \$500.00*
  - *Monitor the CADs and mobile MPS in Kihei CID office.*
- *Computer Monitor/External Screens: \$5,000.00*
  - *Replace 10 new monitors for lab and field locations in Kihei/Wailuku CID offices for advance video displays. External monitors for additional workspace.*

- b. Explain the type of operations the drones will be used for. (TC)

*The drones have been and will be utilized in the assistance with investigations involving missing persons, search and rescue operations, providing officers with overwatch to ensure officer safety, the mapping of crime scenes, and the obtaining of aerial photographs to help with community concerns.*

*The drones have also assisted MFD with an overview of brush fires as well assisting MEMA in documenting and gathering information regarding the post flood event in Kihei. The drones have also been used in gathering photos of roadways and bridges in the Kipahulu area. The drones have been utilized not only by MPD but also other agencies in the County. It is the goal to have these drones readily available for day and night operations for patrol officers but they will also be ready to assist the County of Maui at any time when requested.*

*The funding that is being requested is to ensure that all of the equipment that has been procured over the last several years will be mission ready at all times.*

*The Office of Youth Services grant funds are utilized to support the Positive Outreach Intervention Program by funding overtime services provided by officers and counselors. These funds are also allocated to purchase incentives, such as meals for the families and youth attending, to encourage participation and engagement in the program. There is approximately an 80% success rate for the POI Program. The Juveniles that successfully complete the program stay out of the Juvenile Justice System and have reconnected with their family. Kalo is no longer active and hasn't been for over a year.*

11. As it relates to Repairs & Maintenance – Services/Contracts, Index Code 910083B, explain what repairs the Molokai cottage needs. (Page 20-44, Budget Details) (NUH)

*Renovation/upgrade to the Molokai Police cottages are needed such as replace flooring as it's started to separate, interior painting, waterpipes outside of cottages are degrading with time causing leaks along with normal wear and tear repairs needed.*

- Washer and dryer replacement for both units. One unit fully broken, second unit they use a screwdriver to keep it turning, and dry clothes on clothesline
- Flooring in cottage on the left – tiles chipped up and bad. At minimum would be 340sqft for the front room.
- Various water leaks – kitchen sink faucet in left unit

- Install of water basin / sink outside right unit
- 8 new ac units – 4 in each unit. because of mold, the guys tried cleaning them all out, but they still need replacement
- Tree trimming – get the branches off the roofs
- Replace screen doors on both cottages
- Replace locking door mechanism on left cottage
- Outdoor lighting
- Clothes hanging rack
- New furniture
- Shower head – current one broken and won't stay pointing up

12. As it relates to Computer Software, Index Code 910133B, explain why the Department needs to purchase E-Citation computer software and whether it will be a one-time expense or an annual one. What does the Department use now? (Page-20-48, Budget Details) (TP) (NUH)

*Cost is an annual expense.*

*E-Citations (Thin Blue Line) has been implemented by the Maui Police Department Traffic Division since 2020 and was funded via the HDOT Traffic Grant as a pilot program. HDOT pilot program/funding has come to an end and funding is requested via County Budget to continue with the program. E-Citations have been implemented departmentwide (Patrol) since January 2025.*

*E-Citation enables Officers to issue citations electronically. It is very efficient and much less time consuming, for all involved, from the Officers issuing the citations to the clerks at the Court House processing the citation. Driver's license and Vehicle registration can be scanned at the scene to populate the required data onto the citation, via bar code, eliminating errors and illegible handwriting. Once the citation is issued, it is immediately locked and uploaded into the system, where operators/offenders may go pay their citation at the Courthouse (Traffic Violations Bureau) if they choose to do so. Officers/OOA no longer have to manually input citation data into the Report Writing system, as it was done with traditional paper citations. Eliminates lost citations or citations turned in late by Officers.*

*Since Patrol implementation, users have gone from the original (19) Traffic users, to (250) users departmentwide, to include the Judiciary.*

13. As it relates to Publications & Subscriptions, Index Code 910158B, is the Firearm/Evidence Licensing subscription new? (Page 20-60, Budget Details) (NUH) *These are new management systems that will continue to be annual cost.*

*Cybersecurity for the PI CAD / RMS SYSTEM. There are programs out there (similar to Motorola's cyber assurance program), that will protect our data from major data leaks.*

*No – this would be annual*

*Multiple Prisoner Cells will need plumbing replacement for leaking of sinks and pipes and replacement of plexiglass in all cells.*

- a. Is the maintenance of computer license/software for the implementation of CAD/RMS an annual expense? If yes, why was only \$6,000 allocated for FY 2025? (Page 20-60, Budget Details) (TP)

*This is not for the CAD / RMS. This expense is for the Armada platform that services the Starlinks. This enhanced platform provides MPD the ability to monitor each starlink that MPD will have before the end of this fiscal year. The enhanced access is \$5,400.00*

- b. Why are there requests for CAD/RMS increases both under this item and under Repairs & Maintenance – Services/Contract, Index Code 910430B? (Page 20-63, Budget Details) (TP)

*We are trying to consolidate everything under one bureau so that multiple bureaus aren't spending money which could result in overages or poor accounting. Since technical services has been in charge of the project for the last 2 years, Technical Services has a better understanding of the entire scope of the project and therefore is being asked under Technical Services and not 910430B*

*Consultations with Dispatch are always being done to ensure that Technical Services gets Dispatch what they need. If they are missing something, it will come out of 910430B with the*

*transition to a new Computer Aided Dispatch (CAD) and Report Management System (RMS) to Motorola, it is necessary to pay for the annual maintenance of “interfaces” upon “go live,” which is expected in Quarter 2 of 2025. This means that upon going live with Motorola, it will cost \$600,000 for the maintenance of these interfaces.*

*Covered in the \$600,000 is also paying for the certificates and licenses to the latest version that Motorola is offering, for both our primary server and our secondary (disaster recovery) server.*

*Additionally, it will cost \$1,400,000.00 to cover interfaces for Motorola.*

17. As it relates to Repairs & Maintenance – Buildings, Index Code 910182B, explain what is being refurbished and painted and why the expenditures are necessary. (Page 20-62, Budget Details) (TP)

*The requested refurbishment and painting relate to the antenna towers at 4 of the Public Safety Radio System sites, 2 in East Maui, 1 in Upcountry Maui, and 1 in Molokai. These steel structures require periodic cleaning, corrosion control and painting to extend their life span. 3 of these towers are located in high salt spray corrosive environments.*

18. As it relates to Repairs & Maintenance – Services/Contracts, Index Code 910182B: (Page 20-62, Budget Details) (TP)

- a. How many batteries will be replaced?

*The requested funds are to replace a total of 16 battery plants.*

- b. How many batteries are there in total?

*There is a total of 27 battery plants of the requested type across the Public Safety Radio System.*

- c. What is the average life span of a battery?

*The expected life span of the requested batteries is between 8 and 10 years.*

*Please note that there are 3 types of battery plants in the Public Safety Radio System. The type requested is being replaced in 2 phases to spread the cost out. We have already replaced 6 smaller battery plants (8 years expected life), and are in the process of replacing 11 of the requested battery types. We will need to replace 4 larger battery plants (10 to 12 years expected life) in the FY 2027 cycle.*

19. As it relates to Telephone, Index Code 910430B, explain the Hawaiian Telcom dispatch service. (Page 20-63, Budget Details) (TP)

*General communication dispatch/receiving desk phone line. Correction based on actual.*

20. As it relates to Repairs & Maintenance – Buildings, Index Code 910491B, explain what specific aspects of the station need to be brought into ADA compliance and

how the repairs and maintenance will achieve compliance. (Page 20-64, Budget Details)  
(TP)

*ADA compliance for the building, to bring it up to modern standards, are strictly following the results of the 2023 Bowers and Kubota Building Assessment Report. From that report, this line by line breakdown was created of each item in the report. As a summary, ALL our bathrooms and locker room are lacking ADA provisions, needing plumbing, tiling, and construction of stalls, sinks, hand driers, showers, shower heads, benches, etc. Water drinking stations need to be moved on all levels, fire alarm pull downs all need to be lowered, defib, fire extinguishers, thermostats all need to be lowered, fire alarms need to have ADA lights and ADA sounds. All stairway hand rails need to be extended. All 3 levels need hallway protrusions adjusted, removed and moved.*

21. As it relates to Other Equipment, Index Code 910166C, the quantity lists 35 units but the description indicates 50 Body Armor Sets. Provide the correct amount. (Page 20-65, Budget Details) (TP)

*Correct amount should be \$85,000.00; purchasing of 35 armor sets at \$1,000.00/each and replacement of 50 armor sets.*

22. As it relates to Other Equipment, Index Code 910182C: (Page 20-65, Budget Details)

- a. Explain what “Purchase of Network Expansions” means. (TP)

*These are connections we seek to add to the Radio System Network in order to minimize the effects of single points of failure, and create alternate routes for radio, as well as County voice and data traffic. Areas of concern are East Maui, West Maui, and Moloka‘i. Without getting into system security concerns, an outage at one site can disconnect East Maui, Molokai, and parts of West Maui from the network and isolate these areas. The impact of the fiber optic cables being burned during the Lāhainā Wildfire, as well as the Olinda Fire disconnected West Maui for 3 weeks. This investment seeks to prevent that kind of wide-area outages for Public Safety and County of Maui communications.*

- b. Explain why the Department is requesting to replace only half of its fleet’s portable radios. (GJ)


*The decision to replace only half of the Police Department’s portable radio fleet was to spread this cost over 2 budget cycles in order to reduce the impact of the replacement expenses. The existing radios are beyond support, and we plan to use the replaced radios to keep the remaining users operational until the rest of the radios can be replaced in the 2027 Budget cycle. The radios that are still operational will be placed into caches in order to support unforeseen disasters and emergencies until they eventually cease to operate.*

*For the FY26 \$150k we have set aside, we have strong early indicators that the best option from the consultants for the expansion of officer accommodations will be to knock down the existing*

The \$150k would be used for a year's worth of purchasing the selected drawings, starting all the permits, preparing the land, staging temporary trailer homes for the officers while the cottage is knocked over and prepared for construction with a FY27 budget of money.*
