>> PUBLIC HEARING FOR MAY 12, 2023. PLEASE COME TO ORDER. MADAM CLERK, CAN WE HAVE ROLL CALL. THE MAUI COUNTY PUBLIC HEARING IS NOW CALLED TO ORDER. [ROLL CALL]
>>COUNCILMEMBER TASHA KAMA: ALOHA. I AM AT HOME IN MY WORK SPACE AND THE ONLY PEOPLE HERE. >> COUNCI MEMBER YUKI SUGIMURA: EXCUSED. WE HAVE NO TESTIFIERS WAITING.\r\n\r\nTHANK YOU SO MUCH. >>COUNCILMEMBER GABE JOHNSON: ALOHA CHAIR, COUNCIL MEMBERS, COMMUNITY MEMBERS, THERE ARE NO TESTIFIERS IN THE LANAI DISTRICT OFFICE AND HERE AND READY TO WORK. MAHALO. >>COUNCILMEMBER KEANI RAWLINS-FERNANDEZ: ALOHA KAKOU. I'M IN THE CHAMBERS AND WE HAVE NO TESTIFIERS AT THE DISTRICT OFFICE.
