BILL NO. 184 (2024)

A BILL FOR AN ORDINANCE AMENDING CHAPTER 3.36,
MAUI COUNTY CODE, RELATING TO GRANTS

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. This Ordinance's purpose is to allow direct County homeowner grants to individuals under chapter 3.34, and to exempt those grantees from requirements related to qualifying standards for applicants, reporting, and disbursement limitations.

SECTION 2. Section 3.36.150, Maui County Code, is amended to read as follows:

"3.36.150 Applicability. [All] Except for grants as described in chapter 3.34, all grants of County funds and County real property are subject to this chapter. Nothing in this chapter [shall restrict] restricts the council from appropriating grants for public purposes, except for noncompliance under section 3.36.130, provided that sections 3.36.070 to 3.36.140 [shall] apply.

SECTION 2. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

SECTION 3. This Ordinance takes effect on approval.
