SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2024 BUDGET (REVENUES; DEPARTMENT OF **ENVIRONMENTAL** MANAGEMENT, SOLID WASTE OPERATIONS PROGRAM; FINANCE, COUNTYWIDE COSTS, SUPPLEMENTAL TRANSFER TO THE SOLID WASTE FUND; CAPITAL PROJECTS, IMPROVEMENT DEPARTMENT OF WEST **ENVIRONMENTAL** MANAGEMENT, MAUI COMMUNITY PLAN AREA, SANITATION; AND APPENDIX C, DEPARTMENT OF ENVIRONMENTAL MANAGEMENT. On behalf of the Department of Environmental Management, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2024 BUDGET FOR THE COUNTY OF MAUI, REVENUES; DEPARTMENT OF ENVIRONMENTAL MANAGEMENT, SOLID OPERATIONS PROGRAM; DEPARTMENT OF FINANCE, COUNTYWIDE COSTS,

SUPPLEMENTAL TRANSFER TO THE SOLID WASTE FUND; CAPITAL IMPROVEMENT PROJECTS, DEPARTMENT OF ENVIRONMENTAL MANAGEMENT, WEST MAUI COMMUNITY PLAN AREA, SANITATION; AND APPENDIX C, DEPARTMENT OF ENVIRONMENTAL MANAGEMENT, WEST MAUI COMMUNITY PLAN AREA."

The purpose of the proposed bill is to 1) increase interfund transfers by \$5,200,000, increase Carryover/Savings in the General Fund by \$5,200,000, and adjust Total Estimated Revenues accordingly; 2) amend Department of Environmental Management, Solid Waste Operations Program to increase the appropriation for Category B - Operations & Equipment in the amount of \$4,000,000, and adjust the total appropriation accordingly; 3) amend Department of Finance, Countywide Costs, Supplemental Transfer to the Solid Waste Fund, by increasing Category B - Operations & Equipment in the amount of \$5,200,000 and adjusting the total accordingly; 4) adjust the Total Operating Appropriations to reflect an increase of \$9,200,000 in Category B - Operations & Equipment and adjusting the total accordingly; 5) amend Capital Improvement Projects, Department of Environmental Management, West Maui Community Plan Area, to add a new appropriation under Sanitation, Solid Waste Management Fund, entitled "Lāhainā Wildfire Final Disposition Site" in the amount of \$1,200,000; 6) amend the Total Capital Improvement Project Appropriations to reflect an increase of \$1,200,000; 7) adjust the Total Appropriations (Operating and Capital Improvement Projects) accordingly; and 8) amend Appendix C, Department of Environmental Management, West Maui Community Plan Area, to add a new project and project description entitled "Lāhainā Wildfire Final Disposition Site" in the amount of \$1,200,000.

On October 27, 2023, the Board of Land and Natural Resources approved a 19-acre property in Olowalu for construction of a new landfill to hold an estimated 400,000 tons of ash and debris. The Department of Environmental Management is currently beginning to conduct community outreach to make residents aware of planning efforts to manage debris and solicit feedback, opinions, recommendations, and ideas. No construction costs are included in this funding request.

The \$4,000,000 under the Solid Waste Operations Program will be used for operational costs related to the Final Disposition Site, and the CIP funding will be used solely for permitting and design.
