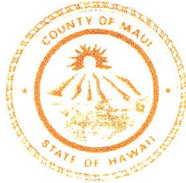

SUBJECT: **AMENDMENTS TO THE FISCAL YEAR 2025 BUDGET  
(ESTIMATED REVENUES; DEPARTMENT OF FIRE AND  
PUBLIC SAFETY, FIRE/RESCUE OPERATIONS PROGRAM)**

I am transmitting a proposed bill, entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2025 BUDGET FOR THE COUNTY OF MAUI, ESTIMATED REVENUES AND DEPARTMENT OF FIRE AND PUBLIC SAFETY, FIRE/RESCUE OPERATIONS PROGRAM."

The purpose of the proposed bill is to amend the Fiscal Year 2025 Budget to: 1) increase Carryover/Savings in the General Fund and Total Estimated Revenues by \$300,000; 2) increase the appropriation for Department of Fire and Public Safety, Fire/Rescue Operations Program, Category B – Operations & Equipment by \$300,000; and 3) increase both Total Capital Improvement Project Appropriations and Total Appropriations by \$300,000.

Due to brushfires in Upcountry Maui that were located in remote locations, multiple helicopters were needed to assist with combating the fires. In addition, dozers, water trucks, and excavators were procured from outside vendors to assist with these fires. \$50,000 of these funds will be used toward the helicopter flight charges and the remaining \$250,000 will go toward other services related to brushfire assistance.



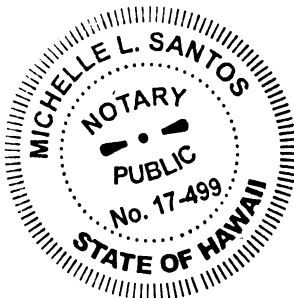


