RELATING TO THE APPOINTMENT OF DEBRA KELLY TO THE MOLOKAI PLANNING COMMISSION

WHEREAS, by correspondence dated April 09, 2021, Mayor Michael P. Victorino notified the Council he nominated Debra Kelly to the Molokai Planning Commission for a term expiring on March 31, 2024, to fill a vacancy replacing Julie-Ann Bicoy, pursuant to Sections 2.28.020 and 2.28.070, Maui County Code, and Sections 8-8.4 and 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and

WHEREAS, Charter Section 13-2, requires the Mayor's nominee to be approved by the Council; and

WHEREAS, Charter Section 13-2(17), requires the Council to approve or disapprove the nomination within sixty days after the Mayor submits the name of the nominee to the Council because of the death, resignation, or removal of a member; and

WHEREAS, Charter Section 8-8.4 contains specific provisions relating to the Molokai Planning Commission; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves the appointment of Debra Kelly to serve on the Molokai Planning Commission for a term expiring March 31, 2024;
2. That the Council expresses its gratitude and appreciation to Debra Kelly for her willingness to be considered for public service and actively participate in County government; and
3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.
