

Attached is a tentative schedule for the FY 2027 Budget Session. Please note that public hearings and meetings will not be officially scheduled until the corresponding agendas are posted.

In preparing the tentative schedule, the following time constraints were observed:

1. Submission of Proposed Budget:

- The Mayor must submit a proposed Budget, Capital Program, and message to the Council on or before **March 25** (§ 9-2(1), Revised Charter of the County of Maui (1983), as amended).

2. Public Hearings on Proposed Budget and Capital Program:

- The Council must conduct a public hearing on the proposed Budget and Capital Program during the period of **April 1-30**. One notice must be published in a newspaper at least two weeks before the public hearing (Charter § 9-4).
- **April 17** is designated as the date for the first public hearing on the proposed Budget and Capital Program.
- Upon the request of three Councilmembers, the Council must conduct a public hearing on any proposed ordinance or resolution (Charter § 4-2(3)).
- **May 15** is designated as the date for the second public hearing on Budget-related ordinances and resolutions to satisfy a potential public hearing request from three Councilmembers.

3. Submission of Certified Tax Roll:

- The Director of Finance must submit the certified assessment list (certified tax roll) on or before **April 19** (Maui County Code § 3.48.135).

4. Public Meeting on Real Property Tax Rates and Tiers:

- The Council must conduct a public meeting on any new Real Property Tax rates and tiers, if applicable, with public notice including the meeting's date, time, and location, and a range of possible rates and tiers, at least 10 days before the meeting (Maui County Code § 3.48.565(A)).

- **April 21** is designated as the date for the public meeting on Real Property Tax rates and tiers. Adoption of the final Real Property Tax rates and tiers will be scheduled on **May 15**.

5. Public Hearing on Fuel Tax Rates:

- The Council must conduct a public hearing on any new Fuel Tax rates, and two notices that include a range of possible rates are required within the 30-day period preceding the hearing (HRS § 243-5; Maui County Code § 3.20.010).
- **May 15** is designated as the date for the public hearing on any new Fuel Tax rates.

6. Public Hearing on Vehicle Weight Tax Rates:

- The Council must conduct a public hearing on Vehicle Weight Tax rates, and a notice of the hearing must be published at least 10 days before the hearing (HRS § 249-13; Maui County Code § 3.24.030).
- **May 15** has been designated as the date for the public hearing on Vehicle Weight Tax rates.

7. Digest of Council Bills:

- A digest of the Council's bills that pass first reading must be published in a newspaper at least three days before second and final reading (Charter § 4-2(4)).
- **June 2** is designated as the date when the Council will consider Budget-related bills on second and final reading; therefore, the digest is set to be published on **May 28**.

8. Deadline for Passage of Budget and Capital Program Bills:

- The Council must pass bills approving the Budget and the Capital Program on second and final reading by **June 10** (Charter § 9-5(2) and 9-6(4)).


