- 1(a). The Affirmative Action Advisory Council is required to meet once per year, but may meet more often if the Council deems it appropriate. The Council met three times in calendar year 2017, once in calendar year 2016, and once in calendar year 2015. Meetings are typically held on a weekday afternoon, but there is no set meeting schedule. The schedule is coordinated by the County's Equal Employment Opportunity Specialist in consultation with the Council, and is based on the member's availability.
- 1(b). Council members who are County employees are not required to use their personal leave to attend the meetings per HRS 78-4(c), which states: "When any employee must be away from the employee's regular work because of service as a member on a board or commission, the employee shall not, as a result of the absence, suffer any loss of the employee's regular salary or wages. The time spent in service as a board or commission member outside of the employee's regular work hours shall not be considered as time worked."
- 1(c). The representative would not be eligible for overtime for service on a board or commission. If a meeting falls within the representative's workday, the representative would be granted leave from their position to attend. If the meeting falls outside of the workday, the time spent would not be considered time worked.

- 3(a). Yes. The County of Maui has an existing contract with Hawaii Gas with an encumbrance balance of \$76,033.65.
- 3(b). Because there were no prior concerns expressed by the public regarding Mr. Ginoza's nomination, the Office of the Mayor did not seek an opinion from the Board of Ethics.

- 4(b). Because there were no prior concerns expressed by the public regarding Mr. Bassford's nomination, the Office of the Mayor did not seek an opinion from the Board of Ethics.

Molokai Planning Commission nominee, Ms. Jaylene Nuesca's immediate supervisor, Mr. Isaac Kan Hai and Public Works Director, Mr. David Goode, have given their approval to allow Ms. Nuesca to participate in weekday meetings as a member of the Molokai Planning Commission should she be confirmed by the Maui County Council.

This letter is in response to your correspondence dated February 15, 2018 to Chief of Staff Araki-Regan regarding the committee's discussion on the above subject. The questions posed in your letter pertaining the Council on Aging are listed below in bold and are followed by the Department's responses.

- Council on Aging: Pursuant to Section 2.34.020, Maui County Code (MCC), if a nutrition project is located within the County, at least one member of the Council on Aging shall be a representative of the nutrition project.
 - a. What programs qualify as nutrition projects in the County?

 Qualifying projects include: Home Delivered Meals and Congregate
 Meals provided by the Senior Services Division (Kaunoa) and Home
 Delivered Meals and Congregate Meals provided by Alu Like.

b. Does at least one member of the current board, or does one of the nominees being considered, meet the requirement? If so, please identify the board member or nominee who meets this requirement, and how the member or nominee meets the requirement.

No current member of the board meets the requirement. The Department is uncertain whether or not any nominees meet the requirement as we do not know the names of individuals currently being considered for placement on the board. If, however, a nominee is a current employee of either the Kaunoa or Alu Like Meals programs, the nominee would meet the requirement.

c. Explain the continued need for the board to have at least one member represent a County nutrition project.

Section 306(6)(D) of the Older Americans Act of 1965, as amended in 2016 indicated advisory councils should consist of program participants, family caregivers, service providers, members of the business community, local elected officials, Veteran's service providers, and members of the general public. Therefore, the only current written requirement that the board include a representative of the nutrition project is Section 2.23.020 of the Maui County Code (MCC). The continued need, therefore, is due solely to the MCC requirement.
