Pursuant to your correspondence dated April 9, 2025, below are the responses to the following:

1. Should the use of General Obligation Bonds instead of General Funds for any of the Department of Fire and Public Safety's CIPs be considered?

Response: The Administration chose to fund all of the Department of Fire and Public Safety's CIPs through the General Fund for Fiscal Year 2026. If the Budget, Finance, and Economic Development Committee identifies other uses for these General Funds there would be no issue with moving eligible projects to General Obligation Bond.

2. Has the County received official notification that the federal funding for the Hā'ikū Fire Station is no longer available? If yes, what is the contingency plan for the construction of the Station? Further, should funds be included for the project in FY 2026? If yes, how much and from what source of funds?

Response: We have received notification that the federal funding for the Hāʻikū Fire Station will not be available in Federal FY2025 as Congress is operating under a full year continuing resolution. The Administration continues to push for inclusion of the funding in Federal FY2026 as a Congressionally Directed Spending appropriation, as the timeline for Federal FY2026 funding does not delay the project. If notification is received that the funding will not be available in County FY2026, the Administration anticipates asking the Council for consideration of a budget amendment to add the funds to the County FY 2026
