Pursuant to Section 3.44.015 H. of the Maui County Code, this letter shall serve as notice that the County of Maui has accepted the Dedication of an Easement for Sewerline Purposes by the Department of Environmental Management - Wastewater Reclamation Section. The parcel is identified by the subject Tax Map Key Number.

Please refer to enclosed Exhibit A for the Legal Description and Exhibit A-1 of an Easement Map & Property Location of the easement.

In addition, the Department of Environmental Management has provided additional information pursuant to Section 3.44.015, F.1 of the Maui County Code.

- 1) **County Funds**: No County Funds used.
- 2) **Project Name**: Sea & Believe LLC

COUNTY COMMUNICATION NO. 21-337

- 3) **Purpose**: For Underground Sewerline Purposes, including manholes and other equipment and appurtenance necessary or expedient for the proper maintenance, operation or repair of such underground sewer pipelines.

The Sewer Easement S-1 is a 10-inch sewerline, that was installed within the Hana Highway right-of-way fronting the subject property. However, the necessary sewer easement area to conduct proper maintenance on the installed sewerline extends into the subject property and needs to be granted to the County of Maui. Although the improvements were installed in 1983, a recorded sewer easement was never obtained in favor of County of Maui. The subject sewer easement area is for the sewer system improvements that serves approximately (125) upstream customers.

- 4) **Dedication**: Sewer system improvements consisting of an existing 10-inch PVC sewerline, installed in 1983. All of the sewer system improvements are confirmed to be located within stated easement areas.
- 5) **Conformance**: Easement locations and widths are acceptable to the Department of Environmental Management and are in conformance with County standards.

DESCRIPTION

**EASEMENT S-1
(for Sewerline Purposes)**

Affecting Lot A of the Hamakuapoko Hui Partition situated at the Kuau, Hamakuapoko, Island and County of Maui, State of Hawaii.

Beginning at the South corner of this easement on the Northwesterly side of Hana Highway, being also the Southeast corner of Lot B of the Hamakuapoko Hui Partition the coordinates of said point of beginning referred to Government Survey Triangulation Station "PUUNENE" being:


8,964.22 feet North

8,599.78 feet East

and running by azimuths measured clockwise from True South:

1. 136° 42' 15" 7.56 feet along Lot B of the Hamakuapoko Hui Partition;
2. 224° 31' 56" 97.22 feet along the remainder Lot A of the Hamakuapoko Hui Partition;
3. 238° 09' 10" 20.95 feet along same;
4. 43° 07' 115.45 feet along the Northwesterly side of Hana Highway to a 1/2-inch pipe;
5. 49° 58' 2.46 feet along same to the point of beginning and containing an area of 701 Square Feet.




