Chair and Members:

Your Parks, Recreation, Energy, and Legal Affairs Committee, having met on March 7, 2017, makes reference to County Communication 17-6, from Council Chair Mike White, relating to litigation matters.

By correspondence dated February 28, 2017, the Department of the Corporation Counsel requested consideration of possible settlement options for tax appeals 14-1-0266, 16-1-0272, 16-1-0326, 14-1-0267, 16-1-0273, and 16-1-0327 by Kaheawa Wind Power, LLC and Kaheawa Wind Power II, LLC. Attached to the request is a proposed resolution entitled "AUTHORIZING SETTLEMENT IN THE MATTERS OF THE TAX APPEALS OF KAHEAWA WIND POWER, LLC AND KAHEAWA WIND POWER II, LLC, TAX APPEAL NOS. 14-1-0266, 16-1-0272, 16-1-0326, 14-1-0267, 16-1-0273, 16-1-0327." The purpose of the proposed resolution is to authorize settlement of the appeals.

Your Committee notes Section 3.16.020(B), Maui County Code, requires Council authorization for any settlement of claims or civil litigation in excess of the authority granted by that provision.

A Deputy Corporation Counsel provided a brief overview of the case. He said the issue in these tax appeals is whether the wind turbines have been properly assessed in the valuation of real property for property tax purposes.

Because the case involves ongoing litigation, the Deputy requested the opportunity to convene an executive meeting.

WHEREAS, the County of Maui, to avoid incurring expenses and the uncertainty of a judicial determination of the parties' respective rights and liabilities, seeks to reach a resolution of this case by way of a negotiated settlement; and

WHEREAS, the Department of the Corporation Counsel has requested authority to settle this case under the terms set forth and discussed in an executive meeting before the Parks, Recreation, Energy, and Legal Affairs Committee; and
