On behalf of the Department of the Prosecuting Attorney, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2026 BUDGET, INCREASING **ESTIMATED** REVENUES, GENERAL BY\$500,000. FACILITIES, NEW APPROPRIATION FOR 24 NORTH CHURCH STREET BUILDING RENOVATIONS FOR \$500,000, AND APPENDIX C, DEPARTMENT OF THE PROSECUTING ATTORNEY, WAILUKU-KAHULUI COMMUNITY PLAN AREA, NEW APPROPRIATION FOR 24 NORTH CHURCH STREET BUILDING RENOVATIONS FOR \$500,000."

The purpose of the proposed bill is to amend the Fiscal Year 2026 Budget to 1) increase Estimated Revenues, Carryover/Savings, General Fund by \$500,000; 2) add an appropriation to Capital Improvement Projects for Department of the Prosecuting Attorney, Wailuku-Kahului Community Plan Area, Government Facilities, General Fund, 24 North Church Street Building Renovations in the amount of \$500,000, 3) increase the Total Capital Improvement Project Appropriations and Total Appropriations by the same amount; and 4) add a new project and project description to Appendix C for the Department of the Prosecuting Attorney, Wailuku-Kahului Community Plan Area, 24 North Church Street Building Renovations in the amount of \$500,000.

These funds will be used for planning and design for the renovations of the 24 North Church Street Building to accommodate the Department of the Prosecuting Attorney. After viewing the vacant spaces on the second and third floor, the Department intends to move 67 employees into those spaces early next year, prior to renovations. The remaining employees will be relocated once the renovations are complete.
