**SUBJECT: HAWAIIAN ELECTRIC, CLEAN ENERGY  
INVESTMENT IN HAWAII (WIT-104)**

Over the past three months, members of the Maui County Council have had numerous requests for meetings from developers of the large-scale solar projects selected in the Hawaiian Electric second-round procurement of renewable energy for Maui. I understand there are now five utility-scale solar projects on Maui that are working on the necessary studies and planning for their Public Utilities Company and County Special Use Permit processes.

Because of the unprecedented number of projects that are now moving simultaneously and anticipated future projects on Moloka'i and Lana'i, there is confusion about what the County is trying to accomplish by procuring all this solar energy. From the meetings I have had with the different developers, I believe this is a tremendous opportunity for our islands and I want to see the County be as helpful as possible.

To that end, I am planning a 90-minute informational meeting in my Water, Infrastructure, and Transportation ("WIT") Committee to cover the overarching goals of the projects from different perspectives. I am inviting a group of panelists to present and answer questions from our WIT Committee members. I believe you, as the Executive Director of Hawaii Clean Power Alliance, could represent the views of the solar developers, the challenges they face, and how our County government can help them succeed.


I am also inviting Scott Glenn, Chief Energy Officer at the Hawaii State Energy Office, to explain what the State's 100 percent renewable energy mandate means for our County and to address related social-equity issues, considering those who cannot realize the full benefits of residential solar power because of the expense or because they live in multifamily housing. Scott Seu, President and CEO of Hawaiian Electric, will be speaking about a clear overview of the Power Supply Improvement Plan, the significance of the utility scale projects that were selected, and what this means for our County's electricity future. Dr. Carl Bonham, Executive Director of the University of Hawaii Economic Research Organization, will be speaking about the business, workforce, and economic opportunities the projects will bring. Alex de Roode, our County Energy Commissioner, will speak about the Administration's support of the projects.

Our plan is to hold this meeting virtually on October 19, 2020 at 1:30 p.m. We will provide a video conference link for you to participate and will be scheduling a practice session with all panelists a couple weeks prior to the Committee meeting. My staff will help schedule this with you.

I look forward to hearing if you will be available for this unique opportunity to help educate our Committee members. The meeting will also be aired on our public access TV station, Akaku.
