AUTHORIZING THE TRANSFER OF AN UNENCUMBERED APPROPRIATION BALANCE WITHIN THE DEPARTMENT OF PUBLIC WORKS, FISCAL YEAR 2023 BUDGET

WHEREAS, Section 9-10(2) of the Revised Charter of the County of Maui (1983), as amended ("Charter"), provides that, upon written request of the Mayor, part or all of any unencumbered appropriation balance may be transferred within a department by resolution or from one department to another by ordinance; and

WHEREAS, Section 7 of the General Budget Provisions in Ordinance No. 5392, Bill No. 69, CD1, FD2 (2022), as amended, ("Fiscal Year 2023 Budget"), states that, unless otherwise provided, appropriations for each program may be disbursed for the following categories of use: (A) salaries, premium pay, or reallocation pay, and (B) operations, services, and equipment; provided the disbursement is within the program and category of use for which it was appropriated; and

WHEREAS, Section 3.B.16. of the Fiscal Year 2023 Budget, relating to the Department of Public Works, sets forth appropriations for the Road, Bridge, and Drainage Maintenance Program – Highway Fund; and

WHEREAS, pursuant to Section 9-10(2) of the Charter, Mayor Richard T. Bissen, Jr. has submitted a written request to transfer an unencumbered appropriation balance of \$300,000 within the Department of Public Works, from the

Fund, Category B (Operations & Equipment), in order to cover a projected \$300,000

shortfall in electricity expense for streetlights; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

General Budget Provisions, and in accordance with the Fiscal Year 2023 Budget, it

does hereby authorize the transfer for the Department of Public Works, of an

unencumbered appropriation balance of \$300,000 from the Road, Bridge, and

Drainage Maintenance Program - Highway Fund, Category A (Salaries), to the

Road, Bridge, and Drainage Maintenance Program - Highway Fund, Category B

(Operations and Equipment), in order to cover a projected \$300,000 shortfall in

electricity expense for streetlights; and
