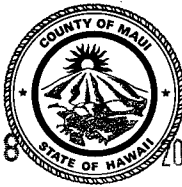

BILL NO. _____ (2016)

A BILL FOR AN ORDINANCE AMENDING SECTION 10.60.042,
MAUI COUNTY CODE, RELATING TO CROSSWALKS ESTABLISHED

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 10.60.042, Maui County Code, is amended by
amending subsection A to read as follows:

“A. Lahaina District. Pedestrian crosswalks are
established in the Lahaina district at the following locations:

1. Not less than twelve feet in width on Front
Street at the entrance to the Puamana Maintenance
Shop [in Lahaina, Maui];

2. Not less than twelve feet in width on
Lahainaluna Road between Mill Street and Kuhua
Street [in Lahaina, Maui];

3. Not less than twelve feet in width on that
portion of Wainee Street, Lahaina, between the Lahaina
Shopping Center and the Lahaina Square, about forty-
seven feet from the entrance to the Lahaina Shopping
Center;

4. On that portion of Front Street in Lahaina,
approximately two hundred fifty-eight feet north of
Wahie Lane;

5. On that portion of Lower Honoapiilani Road
in Honokowai, Lahaina, between Honokowai Park and
Honokowai Superette;

6. Not less than ten feet in width on that
portion of Front Street in Lahaina, approximately one
hundred thirty feet west of Shaw Street;

7. Not less than eight feet in width on that
portion of Front Street in Lahaina, on the south of
Lahaina Shopping Center driveway, approximately one
hundred eighty feet south of Papalaua Street[.];

8. On that portion of Hanawai Street in Napili,
Lahaina, approximately three hundred ninety-five feet
southwest of Napilihau Street."

SECTION 2. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

SECTION 3. This ordinance shall take effect upon its approval.

SUBJECT: PUBLIC WORKS COMMISSION APRIL 27, 2016 AGENDA ACTIONS

The Public Works Commission at its regular meeting of April 27, 2016 voted unanimously in favor of recommending approval to amend the Maui County Code as proposed by three (3) separate Draft Bills for an Ordinance presented as follows:

1. Draft Bill for an Ordinance Amending *Section 10.48.040A, Maui County Code – Related to Stopping, Standing, and Parking*, to delete Pili Street between Market Street and Church Street from the listing. The street is now consolidated into the Wailuku Municipal Parking lot parcel.
2. Draft Bill for an Ordinance Amending *Section 10.48.040.B Maui County Code – Related to Stopping, Standing, and Parking*, on the south side of Nahono Place, from Lower Honoapiilani Road, as prohibited by signs.
3. Draft Bill for an Ordinance Amending *Section 10.60.042B, Maui County Code – Related to Crosswalks Established*, to add a mid-block crossing on Hanawai Street, near the Napili Fire Station.
