A BILL FOR AN ORDINANCE AMENDING
THE FISCAL YEAR 2018 BUDGET FOR THE COUNTY OF MAUI
AS IT PERTAINS TO ESTIMATED REVENUES;
DEPARTMENT OF PUBLIC WORKS,
KIHEI-MAKENA COMMUNITY PLAN AREA, ROAD IMPROVEMENTS,
PAVEMENT REHABILITATION AT VARIOUS LOCATIONS - SOUTH MAUI;
TOTAL CAPITAL IMPROVEMENT PROJECT APPROPRIATIONS; AND
TOTAL APPROPRIATIONS (OPERATING AND CAPITAL IMPROVEMENT PROJECTS)

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 4456, Bill No. 65 (2017), Draft 1, as amended, "Fiscal Year 2018 Budget", is hereby amended as it pertains to Section 2, Estimated Revenues, by increasing Bond Fund in the amount of \$1,852,716; and by increasing Total Estimated Revenues in the amount of \$1,852,716, to read as follows:

SECTION 2. Fiscal Year 2018 Budget is hereby amended as it pertains to Section 4.J.3.a.(1), Department of Public Works, Kihei-Makena Community Plan Area, Road Improvements, Bond Fund, by adding an appropriation for a capital project entitled, "Pavement Rehabilitation at Various Locations – South Maui", in the amount of \$1,852,716, to read as follows:

"J. Department of Public Works

1. Countywide

a. Drainage

(1) Bond Fund

(i) Countywide Drainage Improvements 1,000,000

b. Government Facilities

(1) General Fund

(i) Countywide Facility Building Improvements 500,000

c. Road Improvements (and related improvements, beautification, sidewalks, bike paths, drainage, bridge repairs and maintenance, safety and utilities, accessibility for persons with disabilities) including:

(1) Bikeway Fund

(i) Countywide Bikeway Improvements 97,276

(2) Highway Fund

(i) Countywide Road Resurfacing and Pavement Preservation 5,238,541

(1) Provided, that no less than \$150,000 shall be for road resurfacing and pavement preservation projects on Lanai.

(2) Provided, that no less than \$150,000 shall be for road resurfacing and pavement preservation projects on Molokai.

(ii) Countywide Safety Improvements 500,000

2. Hana Community Plan Area

a. Drainage

(1) Bond Fund

(i) Hana Highway Landslide Repairs Near Mile Post 42 1,150,000

(ii) Waiopai Bridge Repairs 1,500,000

b. Road Improvements (and related improvements, beautification, sidewalks, bike paths, drainage, bridge repairs and maintenance, safety and utilities, accessibility for persons with disabilities) including:

(1) Bond Fund

(i) Keanae Road Safety Improvements 1,000,000

(ii) Lelekea Bridge Replacement 150,000

(2) Highway Fund

(i) Lelekea Bridge Replacement 100,000

SECTION 5. Material to be repealed is bracketed. New material is underscored.

SECTION 6. This Ordinance shall take effect upon its approval.

This bill proposes to amend Ordinance No. 4456, Bill No. 65 (2017), Draft 1, the "Fiscal Year 2018 Budget" of the County of Maui, by amending:

1. Section 2, Estimated Revenues, by increasing Bond Fund in the amount of \$1,852,716; and by increasing Total Estimated Revenues in the amount of \$1,852,716;
2. Section 4.J.3.a.(1), Department of Public Works, Kihei-Makena Community Plan Area, Road Improvements, Bond Fund, by adding an appropriation for a capital improvement project entitled, "Pavement Rehabilitation at Various Locations – South Maui", in the amount of \$1,852,716;
3. Total Capital Improvement Project Appropriations to reflect an increase of \$1,852,716; and
4. Total Appropriations (Operating and Capital Improvement Projects) to reflect an increase of \$1,852,716.
