Mahalo Nui Loa for addressing the needs of the hundreds of residents who reside on Hui F Road in Napili. We are so very much in need of the county taking ownership and jurisdiction over the road.

Hui F Road is very heavily traveled. After heavy rains many potholes appear causing drivers to drive on the wrong side of the road to avoid them. There have been so many near misses with oncoming traffic and traffic merging from side cup de sacs that there is no point counting. It is a miracle that we haven't yet had multiple nasty accidents.

Various residents periodically fill in the holes with cement or other substances in an attempt to make the road safe to drive. However, the band aid fixes are not up to code and quickly erode.

We have also had problems with people abandoning vehicles on our road, further blocking the smooth flow of traffic. It has been very difficult to get anyone to come and remove said vehicles. These are often left on portions of the road that have no parking, thus necessitating swerving into the oncoming lane to get around them.

As with most of the residents on Hui F Road, I am a long term local resident of thirty years standing. I have owned and lived in my unit at Napili Ridge for twenty-one years. Over those years the road has continued to deteriorate and the number of residents on the road has grown considerably. We are all tax payers in Maui County. I think we deserve to be treated like first class citizens with the same services that most of the rest of the law-abiding, tax paying residents of Maui enjoy.

I have lived on Hui Road F for the last 20 years. I own my home on Hui F and also have several rental properties on Hui F. I faithfully pay my property taxes and GET. It certainly seems reasonable to ask that a small fraction of the revenue I have contributed to the County and State over these last 2 decades be used to maintain the source of this revenue.

I also walk Hui Road F nearly every day, on the way to and from Napili Bay for my morning swim. Each day, I witness cars traveling up and down the road, zig-zagging and slaloming to avoid pot-holes. Mahalo for addressing the needs of the many residents who reside on Hui F Road . We are very excited you are considering taking ownership if the road Hui F Road is very heavily traveled. After heavy rains many potholes appear causing drivers to drive on the wrong side of the road to avoid them. There have been so many near misses with oncoming traffic and traffic merging from side cul de sacs that there is no point counting. It really has become hazardous. Not to mention the damage caused to cars that hit them.

We sometimes patch the holes but the fixes only last a week or two as we are not experts nor have access to the right materials.

We have also had problems with people abandoning vehicles on our road, further blocking the smooth flow of traffic. It has been very difficult to get anyone to come and remove these vehicles. There have been cars abandoned in front of Napili Ridges exits (one just a couple weeks ago) that would have blocked access to our property by firetrucks if necessary.

As with many of the residents on Hui F Road, I am a long term local resident of over twenty five years. I have owned and lived in my unit at Napili Ridge the whole time, and I hope to retire here.. Over those years the road has continued to deteriorate and the number of residents on the road has grown considerably. We are all tax payers in Maui County. I think we deserve to be treated like first class citizens with the same services that most of the rest of the law-abiding, tax paying residents of Maui enjoy.

Thanks so much for helping us and I look forward to writing the Maui News a letter thanking the council for their efforts taking control of Hui Rd F.

I am a homeowner on Hui Road F in Napili. This road is a very thickly settled road, with many homes and apartments and hundreds of residents. The road is a dead end, so Hui Road F is the only option for residents to enter and exit their homes.

The road has deteriorated to the point where it is nearly unsafe to drive. Potholes have spawned to develop a labyrinth of cracks, gulleys and holes along the length of the street. Most residents understand that if a car is oncoming, they will wait until the car passes so that the worst of the spots can be avoided by driving along the left, right and center of the road until the smooth part close to the Lower Road.

The condition of the road is especially dangerous when the school buses drop off the children, who must walk in the road due to lack of sidewalks along the majority of the road. Cars driving at this time must avoid the parade of children and the potholes, risking little lives and suspensions and tires.

I purchased my home and began living here October 2014. Since arriving on this street, three (or maybe more) different residents of Hui Road F have tried to fill potholes with 3 different materials, all of which have been sadly temporary.

Aloha to the members of the IEM Committee of the County of Maui,

I was informed just last week that there will be a meeting tomorrow at the courthouse with judges of the 2nd circuit court and representatives of the office of council person Elle Cochran to determine if the County of Maui will be deeded the road at Hui Road F.

If this is this case, I humbly ask the decision-makers to approve Hui Road F be deeded to the County of Maui. This decision would have multiple benefits to the County of Maui and our West Maui community.

I apologize that I cannot attend tomorrow's meeting but I have a previous engagement that I cannot cancel. Nevertheless, as a follow to my wife's email below, I wish to share my thoughts as a Hui Road F homeowner, West Maui community member and a professional real estate broker.
