

Executive Order No. 02389

Setting Aside Land for Public Purposes

By this Executive Order, I, the undersigned, Governor of the State of Hawaii, by virtue of the authority in me vested by Section 171-11, Hawaii Revised Statutes, and every other authority me hereunto enabling, do hereby order that the public land hereinafter described be, and the same is, hereby set aside for the following public purposes:

FOR USE AS A PARK SITE, to be under the control and management of the County of Maui, Department of Parks and Recreation, situate at Waiokama, Lahaina, Maui, State of Hawaii, containing an area of 40,437 square feet, being more particularly described in Exhibit "A" and delineated on Exhibit "B", both of which are attached hereto and made parts hereof, said exhibits being, respectively, a survey description and survey map prepared by the Survey Division, Department of Accounting and General Services, State of Hawaii, both being designated C.S.F. No. 18,170 and dated November 28, 1977.

Said parcel was acquired by Deed dated February 16, 1976, from Maui Land and Pineapple Company, Inc., and recorded in the Bureau of Conveyances in Liber 11649, at page 219, and filed in the land office as Deed No. S-26640.

SUBJECT to disapproval by the legislature by two-thirds vote of either the Senate or the House of Representatives or by majority vote of both, in any regular or special session next following the date of this Executive Order.

Being a portion of Royal Patent 7860, Land Commission Award 7715, Apana 3 to Lota Kamehameha conveyed to the State of Hawaii by Maui Land and Pineapple Company, Inc. by deed dated February 16, 1976 and recorded in Liber 11649, Pages 219-222 (Land Office Deed S-26640).

Beginning at the south corner of this parcel of land and at the north corner of the intersection of Front and Shaw Streets, the coordinates of said point of beginning referred to Government Survey Triangulation Station "LAINA" being 10,183.62 feet South and 2375.00 feet West, thence running by azimuths measured clockwise from True South:-

1. 154° 10' 189.97 feet along the easterly side of Front Street;
2. 244° 30' 210.70 feet along MALU-ULU-0-LELE Park Pumping Plant Site (Governor's Executive Order 1313) and along MALU-ULU-0-LELE Park (Governor's Executive Order 52);
3. 340° 57' 30" 218.56 feet along the remainder of R.P. 7860, L.C.Aw. 7715, Ap. 3 to Lota Kamehameha;
4. 72° 52' 187.00 feet along the northerly side of Shaw Street to the point of beginning and containing an AREA OF 40,437 SQUARE FEET.


