

# Resolution

**No. 26-23**

ACTING ON THE NOMINATIONS OF CRYSTALNANI LEHUA PARK, HEATHER RUTH-DURHAM, KINGDON PAUL VAN NOSTRAND, CORAZON D. BAYLE COX, AND MONICA REBELLA TO THE COUNCIL ON AGING

WHEREAS, the Council on Aging was formed and operates with 15 members under Sections 2.34.020, 2.34.030, and 2.40.010, Maui County Code and Section 349-9, Hawaii Revised Statutes; and

WHEREAS, five vacancies will occur on the Council on Aging, when existing terms expire on March 31, 2026; and

WHEREAS, by correspondence dated January 29, 2026, Mayor Richard T. Bissen, Jr., notified the Council he nominated Crystalnani Lehua Park, Heather Ruth-Durham, Kingdon Paul Van Nostrand, Corazon D. Bayle Cox, and Monica Rebella listed in Exhibit "A," as attached, to fill the vacancies; and

WHEREAS, the nominations are made in accordance with Sections 2.34.020, 2.34.030, and 2.40.010, Maui County Code, Section 13-2, Revised Charter of the County of Maui (1983), as amended, and Section 349-9, Hawaii Revised Statutes; and

WHEREAS, Charter Section 13-2(17) requires the Council to approve or disapprove the Mayor's nomination within 30 days after the Mayor submits the name of the nominee to the Council and, if the Council disapproves the nominee, to immediately notify the Mayor and the Independent Nomination Board of the Council's action; now therefore,

BE IT RESOLVED by the Council of the County of Maui:


1. That it approves the appointment the persons listed on Exhibit "B," as members of the Council on Aging for a term expiring on March 31, 2031;
