WHEREAS, there is a vacancy on the Cost of Government Commission due to the resignation of Gregory Evans on August 11, 2016; and

WHEREAS, the Council was officially notified of Gregory Evans' resignation on February 17, 2017; and

WHEREAS, Section 13-2, Revised Charter of the County of Maui (1983), as amended, (the "Charter") and Chapter 2.41, Maui County Code, outline commission nomination procedures for the Mayor and the Council; and

WHEREAS, the Mayor did not submit a nomination to the Council by the deadline of September 10, 2016; and

WHEREAS, pursuant to Section 13-2(17) of the Charter, in the event the Mayor fails to submit the name of a nominee within the time provided therein, the Council may within sixty days nominate and approve an individual to fill the vacancy; and

WHEREAS, the Council is currently within its sixty-day period, which will expire on April 18, 2017, to nominate and approve the appointment of an individual to fill the vacancy; and

WHEREAS, Sharron Courter has indicated a desire to be appointed to the Cost of Government Commission for a term expiring March 31, 2018, and has submitted a completed application form with the information required by Section 2.41.020, Maui County Code; now, therefore,
