A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2026 BUDGET, COUNCIL SERVICES PROGRAM, OFFICE OF THE COUNTY COUNCIL FOR AMENDMENT NO. 1 TO GRANT G5401, SUSTAINABLE MOLOKAI

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance 5816 (2025), as amended, "Fiscal Year 2026 Budget," is amended as it relates to Section 3.A.2.a., Office of the County Council, Council Services Program, by adding an appropriation for \$50,000 for Amendment No. 1 to Grant G5401, Sustainable Molokai, to read as follows:


