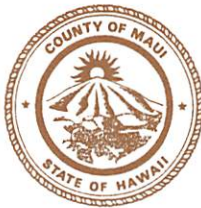

SUBJECT: AMENDMENT TO THE FISCAL YEAR 2019 BUDGET

On behalf of the Department of Housing and Human Concerns, I am transmitting the attached proposed bill for the purpose of amending Appendix A, Part II of the Fiscal Year 2019 Budget as it pertains to the Kaunoa Senior Services Leisure Program Activities Revolving Fund by increasing the appropriation for Leisure Program Activities by \$110,000.

The additional appropriation is needed due to the FY 2019 adopted transfer of 11.0 EP for Leisure Program Instructors funded through the General Fund to the Kaunoa Senior Services Leisure Program Activities Revolving Fund. The EP transfer did not include the corresponding appropriation of \$150,000 to fund the salaries for the instructors.

The Kaunoa Senior Services Leisure Program Activities Revolving Fund currently includes a \$240,000 appropriation for Leisure Program Activities. In addition to \$150,000 in salaries, Kaunoa anticipates utilizing \$200,000 towards program activities this fiscal year.

A BILL FOR AN ORDINANCE AMENDING APPENDIX A
OF THE FISCAL YEAR 2019 BUDGET FOR THE COUNTY OF MAUI
AS IT PERTAINS TO PART II, SPECIAL PURPOSE REVENUES -
SCHEDULE OF REVOLVING/SPECIAL FUNDS FOR FISCAL YEAR 2019,
KAUNOA SENIOR SERVICES LEISURE PROGRAM
ACTIVITIES REVOLVING FUND

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 4861 Bill No. 57 (2018), as amended, "Fiscal Year 2019 Budget", Appendix A, Part II, Special Purpose Revenues – Schedule of Revolving/Special Funds for Fiscal Year 2019, is hereby amended as it pertains to the Kaunoa Senior Services Leisure Program Activities Revolving Fund, by increasing the appropriation for Leisure Program Activities in the amount of \$110,000, to read as follows:

(2) Provided, that disbursements for leisure program instructors are limited to 11.0 Limited Term Appointments.
