AUTHORIZING ADDITIONAL COMPENSATION FOR THE EMPLOYMENT OF SPECIAL COUNSEL ES&A, INC., A LAW CORPORATION, IN *CHELSEIE EVANS, INDIVIDUALLY AND AS THE PERSONAL REPRESENTATIVE OF THE ESTATE OF TRE' PU'UWAILA'AHIAOLOPAKAAMELEHUANANI EVANS-DUMARAN, DECEASED, V. SCOTT MARTIN*, CIVIL 2CCV-24-0000034, UNDER CHARTER SECTION 3-6(6)

WHEREAS, by Resolution No. 24-105, CD1, the Council authorized the employment of special counsel ES&A, Inc., to represent defendant Scott Martin, an employee of the Department of Fire & Public Safety, in the case of *Chelsie Evans, Individually and as the Personal Representative of the Estate of Tre' Pu'uwaila'ahiaolopakaamelehuanani Evans-Dumaran, Deceased, v. Scott Martin*, Civil 2CCV-24-0000034; and

WHEREAS, by Resolution 25-52 the Council authorized an increase in compensation for the employment of special counsel ES&A, Inc. to represent defendant Scott Martin in current and anticipated legal actions by \$150,000, for a total compensation not exceeding \$200,000; and

WHEREAS, the Department of the Corporation Counsel has requested authorization to raise the compensation limit for the employment of special counsel for defendant Scott Martin, by an additional \$250,000 for a total compensation not exceeding \$450,000; and

WHEREAS, in accordance with Section 3-6(6) of the Revised Charter of the County of Maui (1983), as amended, the Council alone is authorized to retain or employ special counsel adopted by a two-thirds vote; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That the Council authorizes additional compensation for the employment of special counsel ES&A, Inc., A Law Corporation, in *Chelsie Evans, Individually and as the Personal Representative of the Estate of Tre' Pu'uwaila'ahiaolopakaamelehuanani Evans-Dumaran*,

Deceased, v. Scott Martin, Civil 2CCV-24-0000034, under
Charter Section 3-6(6);

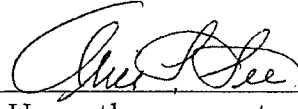
2. That Council authorizes an increase of \$250,000, for a total compensation not exceeding \$450,000; and
