

Please see written responses in *italics* to the questions posed in the April 18, 2024, correspondence to the Office of Council Services.

1. The following relates to the \$250,000 mobile trailer that will serve as the West Maui Residency Area Office ("RAO").
 - a. If purchased by the County, is it possible for the mobile trailer to be reimbursed by the Federal Emergency Management Agency ("FEMA")? Would this purchase be considered a necessary, disaster-related expense?

We are seeking clarification from FEMA on the restrictions for reimbursements.
 - b. Is the plan to place the mobile trailer at the Lahaina Recreation Center?

Currently, there is no plan.
 - c. The Nāpili Park Emergency Community Resource Center, or Nāpili Noho, has encountered difficulties with obtaining a permit and space for their trailer. But FEMA was able to find space for its own mobile trailer on County land. Does OCS foresee any issues with obtaining a permit for the proposed West Maui RAO trailer? Are federal agencies subject to County permitting requirements?

From our knowledge, Nāpili Noho submitted their preliminary permit request on April 18; therefore, we were unaware of any previous difficulties they encountered. OCS does not foresee any issues with obtaining a permit once a location is identified
