Amendment Summary Form

Legislation: Bill 78, CD1 (2023), establishing a new Chapter 3.50, Maui County Code, creating an Immigrant Services Division United States Passport Application Acceptance Facility Revolving Fund.

Proposer: Yuki Lei K. Sugimura, Chair *Yuki Lei K. Sugimura*
Budget, Finance, and Economic Development Committee.

Description: Amend Bill 78, CD1, to clarify the fee that will be deposited into the fund and that the fee will be set in the annual budget ordinance.

Motions: Move to amend Subsection 3.50.030(A), by:

1. Inserting "passport application acceptance" between "all" and "fees;"
2. Inserting after "County of Maui" the phrase "as set in the annual budget ordinance;" and
3. Striking "for the immigrant services division's designation as a United States passport application acceptance facility" before "must be deposited into the fund."

BILL NO. 78, CD1, FD1 (2023)

A BILL FOR AN ORDINANCE TO ESTABLISH A NEW CHAPTER 3.50, MAUI COUNTY CODE, CREATING AN IMMIGRANT SERVICES DIVISION UNITED STATES PASSPORT APPLICATION ACCEPTANCE FACILITY REVOLVING FUND

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Title 3, Maui County Code, is amended by adding a new chapter to be appropriately designated and to read as follows:

“Chapter 3.50

IMMIGRANT SERVICES DIVISION UNITED STATES PASSPORT APPLICATION ACCEPTANCE FACILITY REVOLVING FUND

Sections:

3.50.010	Fund establishment.
3.50.020	Purpose.
3.50.030	Deposits to the fund and use.
3.50.040	Administration.

3.50.010 Fund establishment. There is established and created a fund to be known as the “Immigrant Services Division United States Passport Application Acceptance Facility Revolving Fund.”

3.50.020 Purpose. The fund is established for the purpose of implementation and management relating to immigrant services division’s designation as a United States passport application acceptance facility.

3.50.030 Deposits to the fund and use. A. All passport application acceptance fees paid to the County of Maui, as set in the annual budget ordinance, must be deposited into the fund.

B. Any balance remaining in this fund at the end of the fiscal year will not lapse, but must remain in the fund accumulating from year to year.

C. The revenues in this fund may not be used for any purpose except those purposes listed in section 3.50.020.

D. The director of human concerns must be responsible for the management of the fund.

3.50.040 Administration. A. The director of finance must establish a separate account to record all revenues credited to, and expenditures from, the revolving fund.

B. Any proposed appropriation will be submitted to the council for approval as a budget appropriation in either the annual budget ordinance or a proposed amendment to the annual budget ordinance.”

SECTION 2. This Ordinance takes effect on approval.
