The Board

- ▶ Created to provide for more efficient coordination of State efforts to comply with disability access and civil rights laws through outreach and voluntary compliance.
- ▶ Administrative rulemaking authority for facility access, communication access, and accessible parking.



DCAB Organization

- ▶ 17 Governor appointed volunteer board members
- ▶ Comprised of persons with disabilities, parents or guardians of persons with disabilities, public and private providers of service, and other professionals with knowledge in the areas for which the Board has rulemaking authority.
- ▶ Administratively attached to the Department of Health
- ▶ 21 staff positions

PARKING LOT REQUIREMENTS

- ❖ Applies to ADA Title II (state and local government) and ADA Title III places of public accommodation (private business).

Total Parking Spaces	No. of Accessible Parking Spaces
1 - 25	1
26-50	2
51-75	3
76-100	4
101-150	5
151-200	6
201-300	7
301-400	8
401-500	9
501-1000	2 percent of total
1001+	20 spaces plus 1 for every 100 over 1,000

- ❖ One of every 6 reserved accessible spaces must be van accessible.

ACCESSIBLE PARKING SPACE REQUIREMENTS

- ▶ A standard accessible parking space is 8' wide with a 5' wide access aisle.
- ▶ A van accessible parking space is 11' wide with a 5' wide access aisle, or 8' wide with an 8' wide access aisle. The extra space allows for deployment of a side-mounted lift or ramp. The space is not reserved only for vans or vehicles with a side-mounted lift or ramp.
- ▶ If two parking spaces share the access aisle, a wider access aisle is preferred because it makes both spaces "van accessible." If an accessible space is solo, the wider space is preferred to discourage parking in the access aisle.



VAN ACCESSIBLE ACCESS AISLE REQUIREMENTS - SIGNAGE

- ▶ If the 8' wide access aisle design is used, to deter vehicles from parking there, this 12" x 18" **NO PARKING ACCESS AISLE** sign must be posted:



ACCESSIBLE PARKING SPACE REQUIREMENTS - SIGNAGE

Reserved spaces must have this 12" x 18" sign posted:



ACCESSIBLE PARKING SPACE REQUIREMENTS - SIGNAGE

- ▶ The reserved parking sign shall be mounted at minimum 60" above the finished floor to the bottom of the reserved parking sign. The reserved parking sign shall be mounted on a free-standing pole, on a wall, or suspended overhead. The reserved parking sign shall not be mounted so as to obstruct ingress to, or egress from, a vehicle parked in the parking space.
- ▶ A van accessible parking space must also have this 6" x 12" sign posted immediately below the no "parking sign" with its bottom edge 60" above the finished floor.

VIOLATIONS AND PENALTIES

- ❖ Fail to properly display a valid permit while parked in a reserved parking space: \$25 - \$100 fine.
- ❖ Parking in an access aisle: \$250 - \$500 fine.
- ❖ Parking in a reserved parking space with no permit or using an expired permit: \$250 - \$500 fine.
- ❖ Failing to present an ID card to an enforcement officer upon request: \$250 - \$500 fine.*
- ❖ Using a valid permit assigned to someone else: \$250 - \$500 fine and confiscation of the permit.
- ❖ Counterfeiting or altering a parking permit or ID card: misdemeanor up to \$2000 fine and confiscation of the permit.*
- ❖ Not displaying a valid DPPEP or exceeding the exempt time period in a parking space requiring payment: whatever the fine would be for non-payment.

* ID CARD

- ▶ An ID card is issued with every placard.
- ▶ The ID is on blue card stock and designed to fit in a wallet.
- ▶ Shows the special license plate number, placard number, expiration date, permittee's name, DOB, height, weight, and gender.

Existing Statute

- ▶ **HRS §291-58 Requirement to provide parking for persons with disabilities; penalty.** Beginning July 1, 2002, any public or private entity that provides a parking space reserved for persons with disabilities shall comply with this part and any administrative rules adopted under this part. A private entity that fails to comply with this section shall be fined not less than \$250 nor more than \$500 for each separate offense. Each day of violation shall constitute a separate offense. Any action taken to impose or collect any penalty provided for in this section shall be considered a civil action. [L 2001, c 297, pt of §1]

Proposed Legislation

SB 384 SD1 HD2 - RELATING TO ACCESS FOR DISABLED PERSONS.

Authorizes each county to adopt ordinances to enforce the design and construction requirements for the provision of accessible parking spaces, including the establishment of penalties for failure to comply with the ordinance. Authorizes officials appointed by a county to enter the property of places of public accommodation to enforce violations of the county ordinances. Effective 6/30/3000. (HD2)
