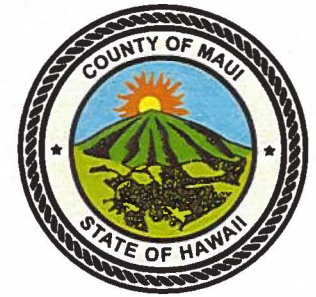


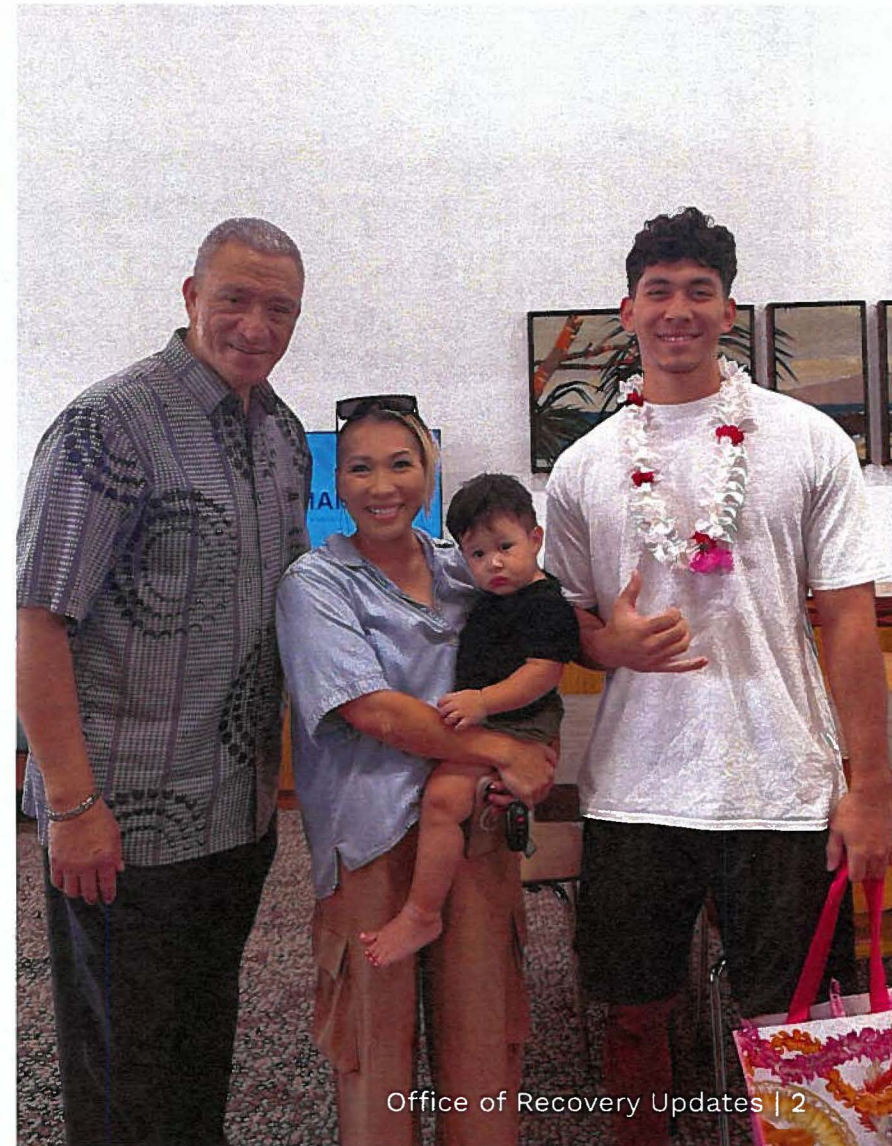

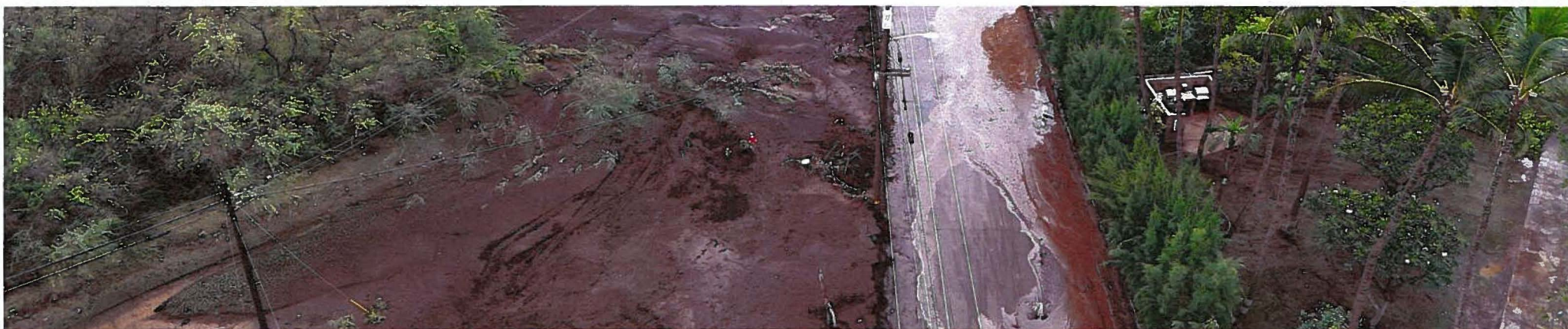

Kona Storm 2026



MEMA (reponse lead)

Leads emergency response, situational awareness, and damage assessment.



**Office of Recovery
(Task Force Coordination)**

Supports coordination across departments and helps ensure recovery planning begins early.



**County Departments
(Operations & Debris Removal)**

Carry out on-the-ground work such as roadway clearance, debris removal, and infrastructure repair.

Office of Recovery

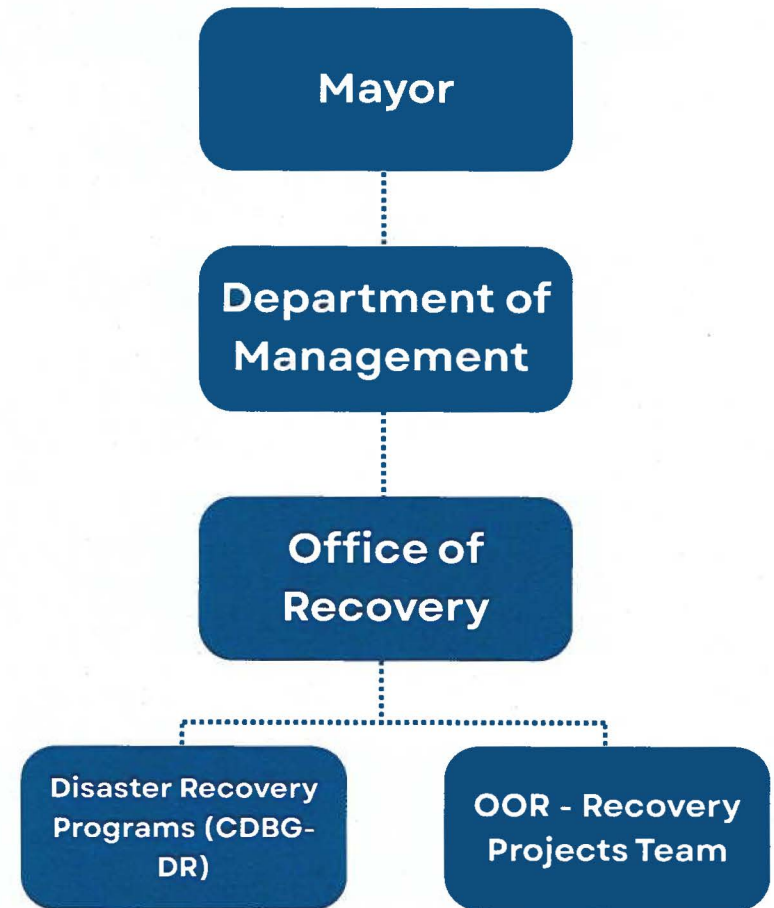
Located within the Department of Management, the Office of Recovery coordinates Maui's long-term wildfire recovery efforts across County departments.

- Implementation of federally funded housing and disaster recovery programs.

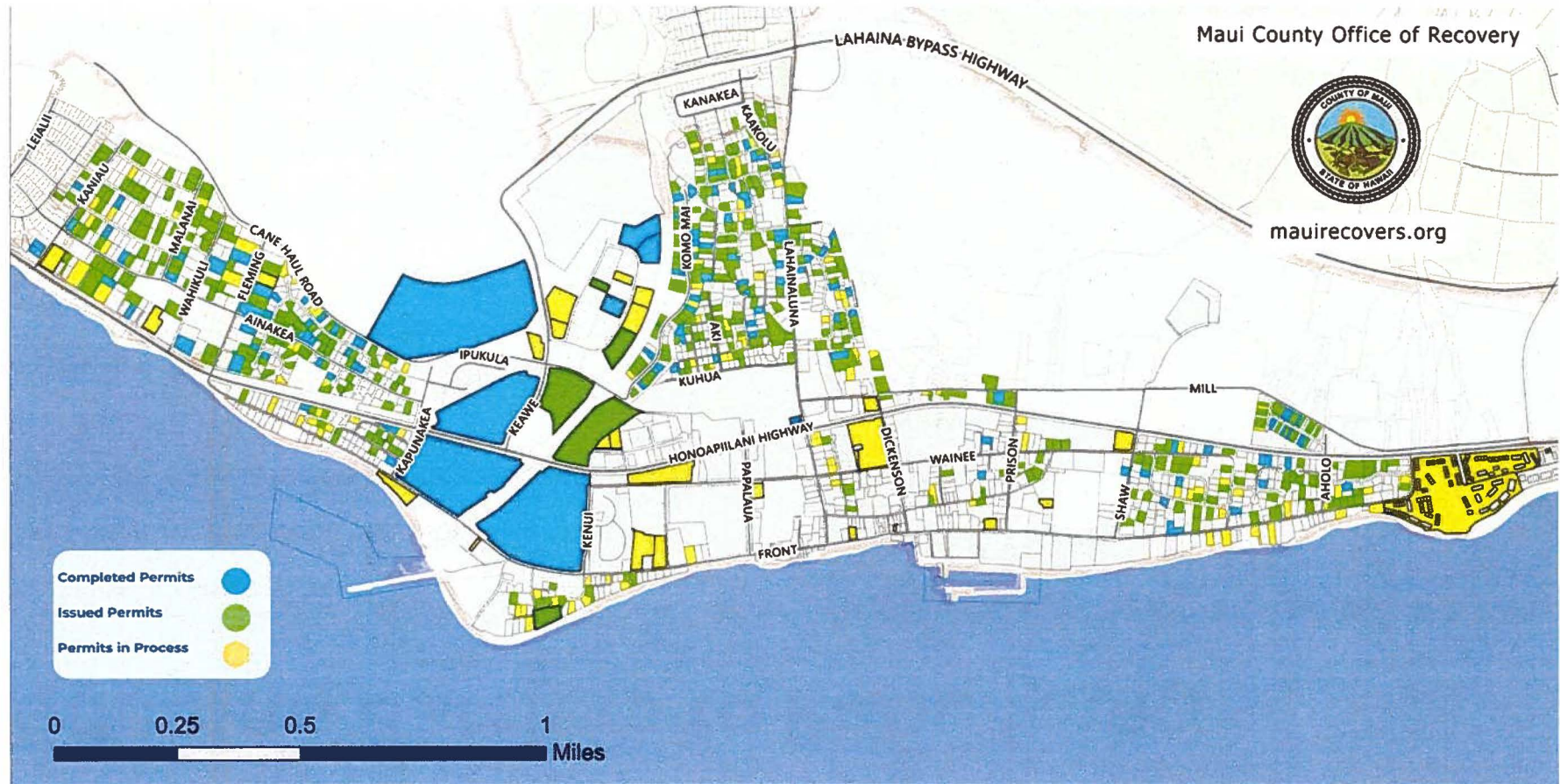

Reducing Barriers to Rebuilding

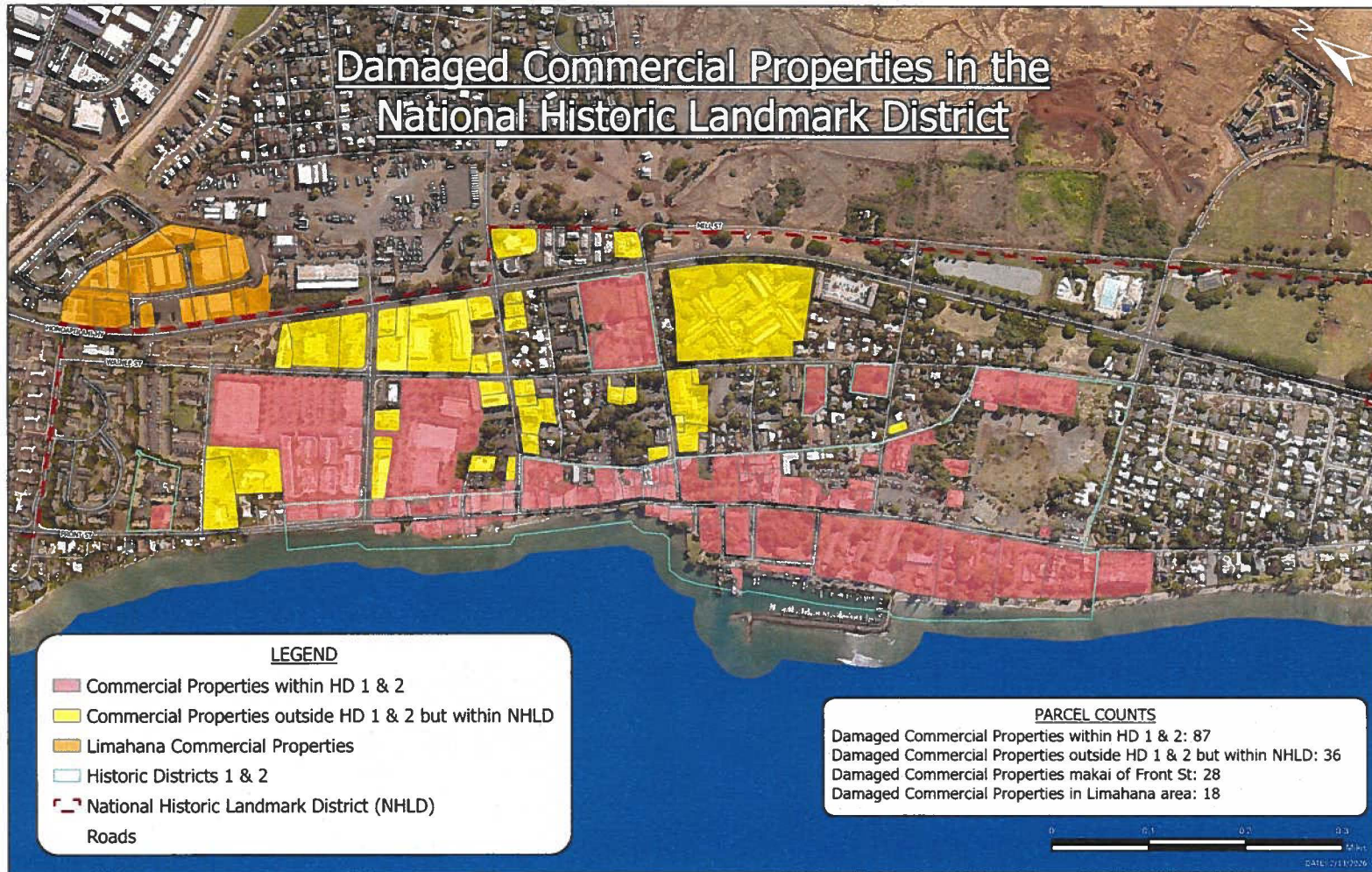
Permitting & Code Flexibility

- SMA review waived (mauka of Front St.)
- Right-of-way & parking requirements waived (Front St. & Historic District)
- Streets code updated to allow balconies and awnings

Clear Design & Review Pathway

- New Historic District design guidelines developed for post-fire rebuilding
- Administrative review pathway created for projects meeting the guidelines

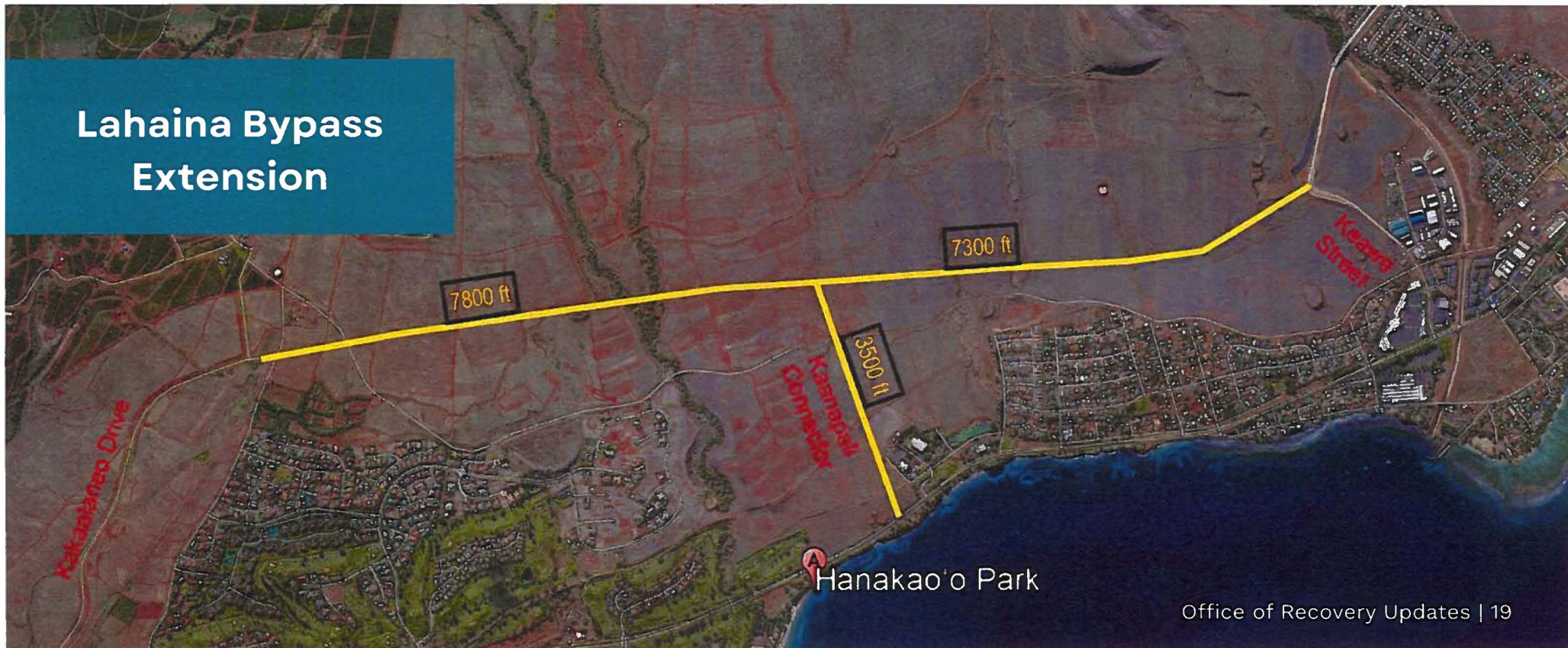

Lahaina Bypass Extension

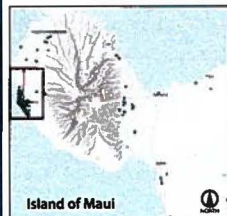

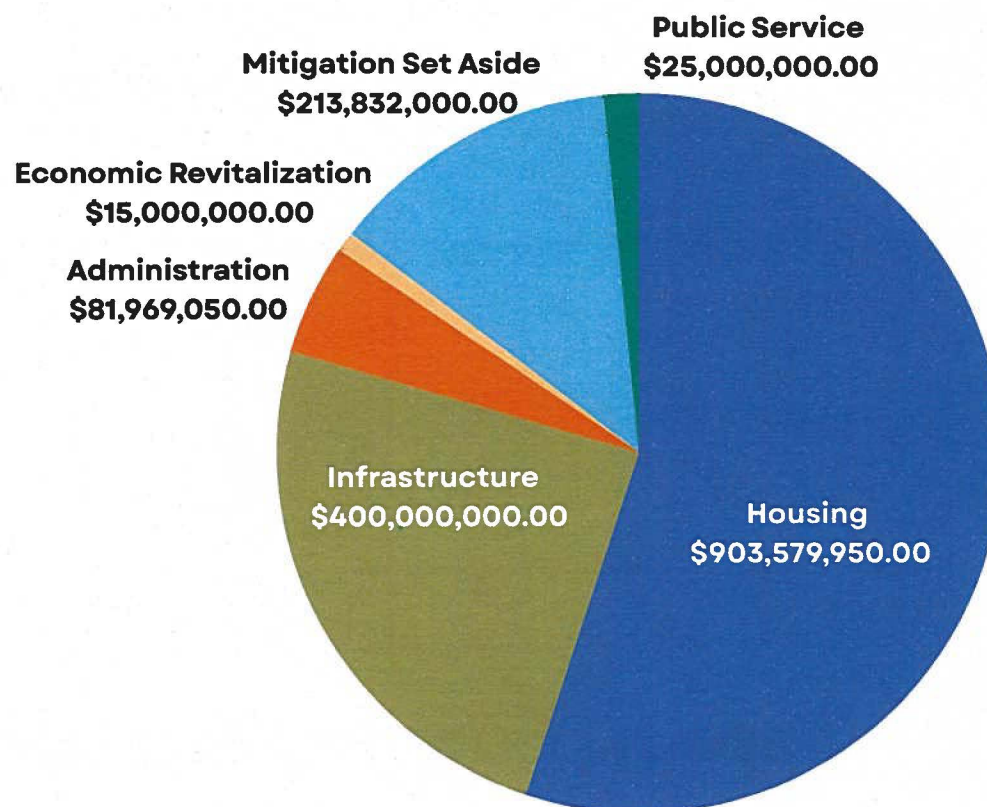


Program Budgets

How CDBG-DR (Disaster Recovery) funds recovery projects:

Funding to programs is guided by HUD national objectives through a community-led, CDBG-DR Action Plan.

**CDBG-DR Funds: \$1,639,381,000
allocated by program**



Infrastructure Recovery Funding Needs



Unfunded Need \$950 million

- County Disaster Funds (CDBG-DR) \$613 million**
- Other Federal and State Funds \$459 million**
- Planned County Funds (Y27&Y28) \$193 million**
- Committed County Funds (Y25&Y26) \$92 million**

Policy Updates – County

Key Policy Actions Supporting Recovery

Housing & Development Flexibility

- Bill 47 (2026) – Updates off-street parking requirements for housing

Rebuilding Lahaina

- Ordinance 5947 – Updated Community Plans relating to building height
- Factory-Built Housing (Bill 15, 2026) – Expands options for rebuilding in the burn zone
- Ordinance no. 5898 Bill no. 156,CD1 (2025), amending MCC 12.52 relating to encroachments on public right-of-way.

Increasing Housing Supply

- ADU Expansion (Reso 25-203) – Supports Act 39, allowing two ADUs on eligible parcels
- Bill 27 (2026) – Updates size limits for accessory dwellings

Lahaina Harbor Reopening

- Harbor reopened to limited activity in December 2025

Lahaina Business Project

- Lahaina Town Action Committee

 Rebuilding King Kamehameha III Elementary School (lost in fire).

Lahaina Rebuild Plan:

 A comprehensive framework guiding post wildfire recovery, land use, infrastructure, and community revitalization in Lahaina.

Royal Complex Study:

 A planning and cultural resource study evaluating preservation, access, and long term stewardship of the Lahaina Royal Complex.

Lahaina Harbor Access:

Restoring access, circulation, and functionality at Lahaina Harbor to support community, commercial, and emergency needs.

County of Maui Wainee Lands:

Master planning of County owned Walnee Lands for future public uses, connectivity, housing, and community facilities.

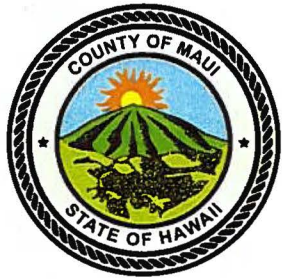

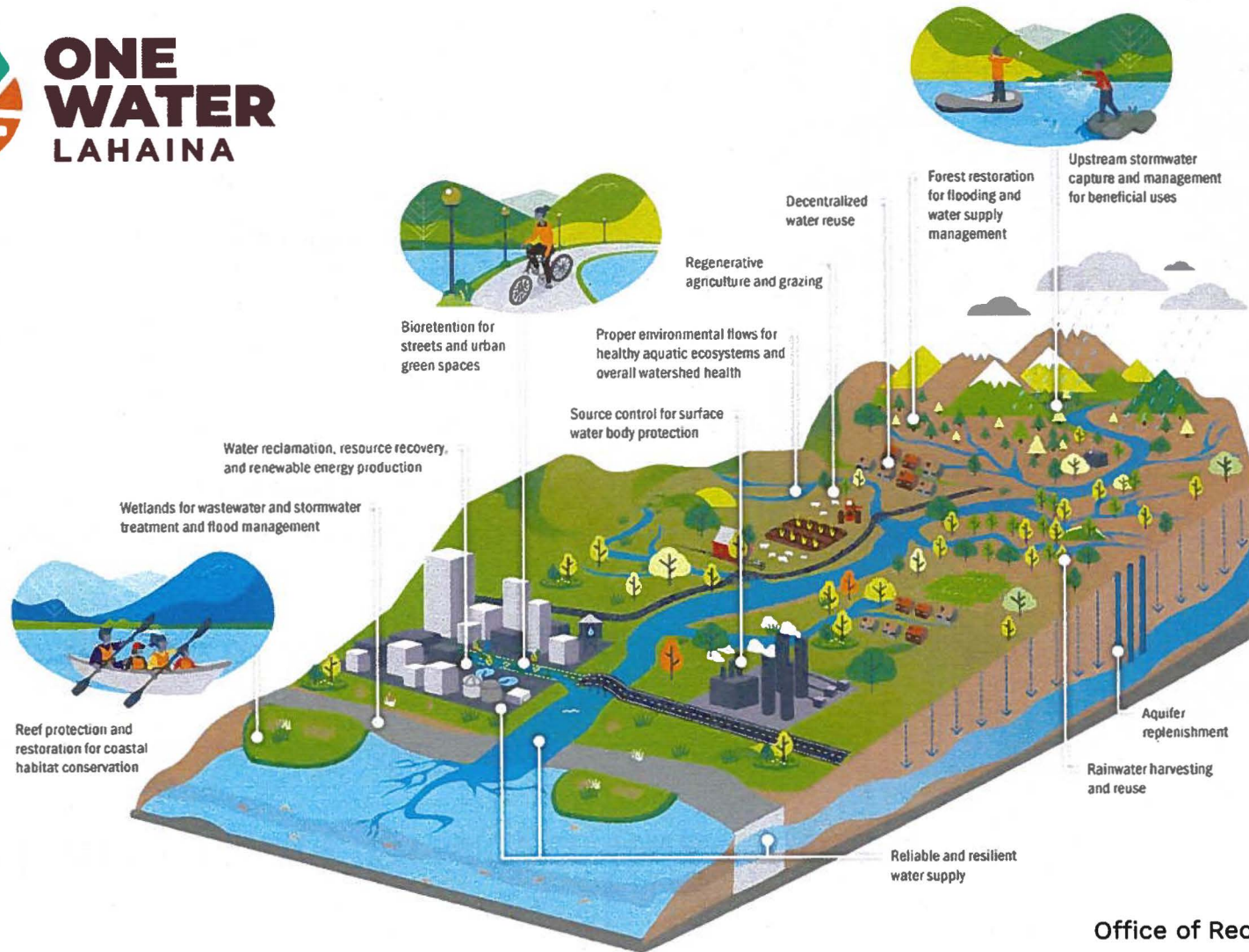

Strengthening Disaster Response Systems

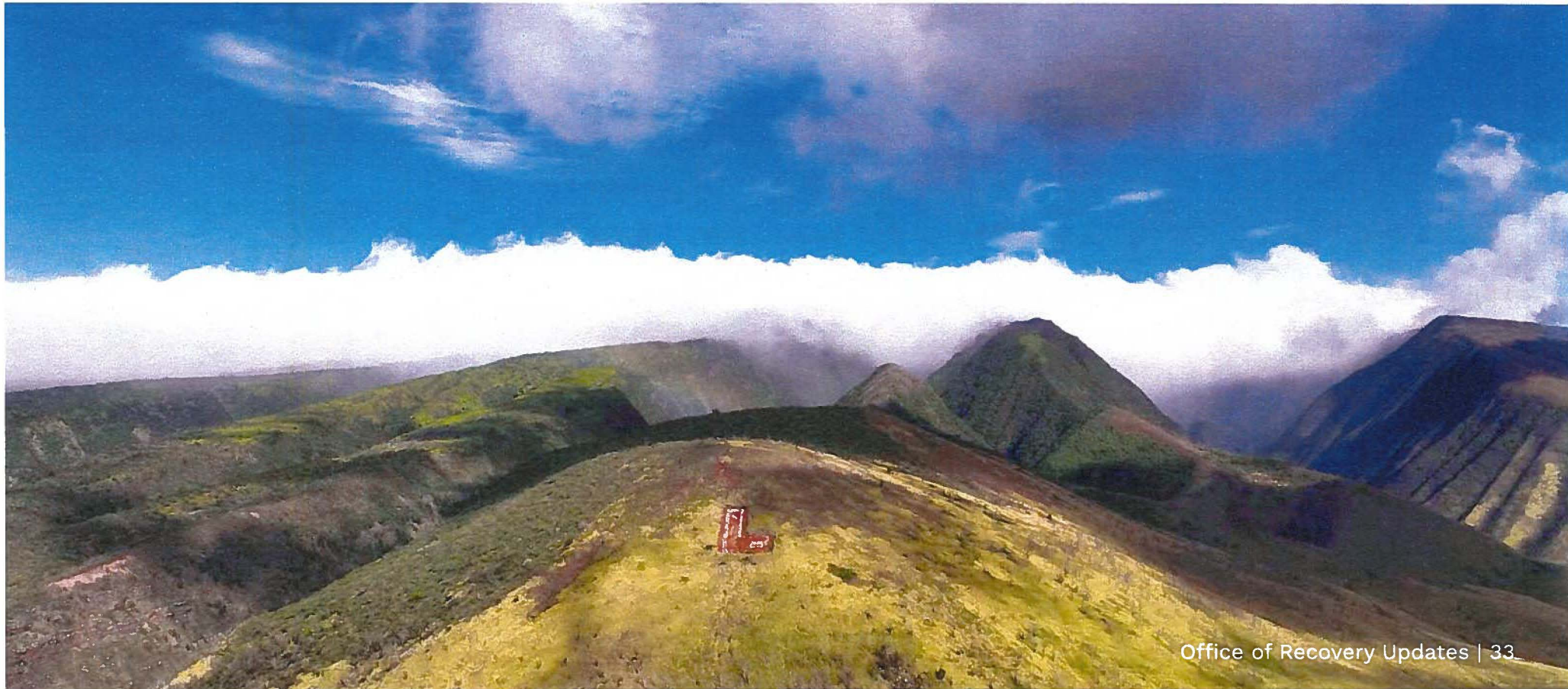
- Coordination with MEMA and HIEMA to strengthen readiness

A Coordinated County Effort

Disaster response and recovery involve many partners working together.

Maui County agencies are coordinating closely with:

- Maui Emergency Management Agency
- County departments
- State and federal partners
- Technical experts supporting response efforts

Through this collaboration, Maui County aims to restore safety, access, and community stability as quickly as possible.

Community Cleanup and Debris Disposal

Community members often begin cleanup quickly following a storm or disaster event. Maui County is working to provide guidance on safe and appropriate debris disposal.

Available disposal locations include:

- Central Maui Landfill
- Hana Landfill
- Moloka'i Landfill

Residents should check the County Solid Waste website for current landfill hours and accepted materials.

Additional services or locations may be announced as cleanup progresses.

Debris Management Coordination

Following severe weather or disaster events, debris management is an important early step in restoring access and safety.

Maui County is coordinating debris management efforts across departments to support safe and efficient cleanup.

Initial priorities include:



Clearing roadways and rights-of-way



Restoring access to critical infrastructure and facilities



Coordinating debris collection and disposal



Identifying appropriate disposal locations

A coordinated approach helps restore normal operations as quickly as possible.

Tracking Impacts and Recovery

County teams are documenting impacts and cleanup efforts across affected areas.

Documentation efforts include:

- Field photography and mapping
- Aerial imagery and drone documentation
- GIS mapping of impacted areas
- Infrastructure assessments



This information helps guide response efforts and informs long-term recovery planning.
