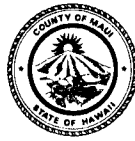

May I please request the following:


