SUBJECT: RESPONSE REGARDING INDEPENDENT NOMINATION BOARD (GREAT-5(7))

Thank you for the opportunity to appear at the Maui County Council's Government Relations, Ethics, and Transparency Committee on September 12, 2024 at 1:30 p.m. I and Vice Chair Sullivan accept and will be available to address your questions as submitted to the Independent Nomination Board (the "INB") on August 30, 2024. Per your request, please see the INB responses to the questions listed below regarding the duties and processes of the INB.

1. Will the INB notify the Maui County Council when a list of nominees for boards and commissions are sent to the Mayor's office? Will the INB also send the Council vacancy notices when resignation letters are received by the Mayor's office?

INB response to question no. 1. is separated into two:

i. <u>List of Nominees</u>: Pursuant to Section 13-2.18. of the Revised Charter of the County of Maui (1983), as amended ("Charter"), the INB is required to transmit a list of applicants or candidates for nomination to fill a vacancy to the appointing authority (either the Mayor or Council) within a prescribed period of time.

Should a meeting include the transmittal of a list to an appointing authority the INB is agreeable and willing to extend the courtesy of a notification that summarizes actions taken on agenda items related to application review or the number of applicants placed on a board or commission vacancy list to the "non-appointing authority" (either the Council or the Mayor) within 10 days of a meeting. See sample summary example below.

- ii. <u>Notification of Vacancies</u>: The INB does not directly receive resignations, withdrawals, or removals nor are they within the duties of the INB to process. The INB Chair is notified during agenda preparation by the Office of the Mayor and the assigned Deputy Corporation Counsel of any recent resignations, withdrawals or removals at which point they are placed on an agenda for notification to the remaining INB members. I defer any further questions to Corporation Counsel.
- 2. INB meeting minutes have not been posted on the County of Maui's website. May I please ask you to transmit copies of the minutes for all INB meetings and to upload the minutes to the website so they are publicly available?
 - We have requested staff to post summaries of meeting actions and audio transcripts to the County's INB's webpage within the next 21 days or as soon as reasonably possible Written minutes per the Sunshine Law for boards, commissions, and committee meetings are required to be electronically available on the board's website for the public within 40 days after a meeting pursuant to Chapter 92, HRS section 92-9(b)).

We understood that pursuant to Governor Josh Green's Emergency Proclamations 1 thru 16 Related to the Maui Wildfires (put in place August 8, 2024) the following suspension was/is applicable to the INB though not indefinite.

- **"2. Suspension of Laws** "Chapter 92, HRS, **public agency meetings and records**, as follows: section 92-3.7(a), to suspend the physical location requirement for Maui-based boards; section 92-15, for boards with Maui-based members, to suspend the quorum requirements, and to the extent the absence of Maui-based members would prevent a board from meeting them, the voting requirements under section 92-4(a) (executive meetings); section 92-9(b), for Maui-based boards, to suspend the deadline for posting minutes; and section 92-3.1(a), for limited meetings of any board related to the emergency, suspend the requirement for the board's vote and concurrence by the Office of Information Practices."
- Please note, Video recordings of INB meetings are posted and available on the INB designated webpage for the public as soon as practicable (formatted and approved by Akaku). Availability can vary from 3 days upwards but required within 40 days after the meeting pursuant to Chapter 92, HRS section 92-9(b).
