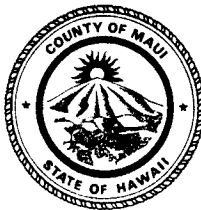


WHEREAS, Section 13-2, Charter, requires the Mayor's nominee to be approved by the Council; and

BE IT RESOLVED by the Council of the County of Maui:

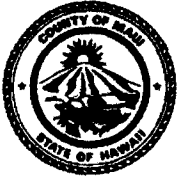
1. That it approves the appointment of Zane Lacaden to serve on the Commission on Children and Youth for a term expiring March 31, 2021; and
