Chair and Members:

Your Economic Development and Budget Committee, having met on June 20, 2019, makes reference to County Communication 19-157, from the Director of Finance, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 2.44, MAUI COUNTY CODE, RELATING TO BOND COVERAGE FOR MEMBERS AND SUBORDINATES OF THE MAUI REDEVELOPMENT AGENCY."

The purpose of the proposed bill is to amend Chapter 2.44, Maui County Code, to permit the Director of Finance to procure a bond for the members and subordinates of the Maui Redevelopment Agency in accordance with Section 53-2(b), Hawaii Revised Statutes ("HRS").

Your Committee notes HRS Section 53-2(b) states, in part: "Each member shall be required to give bond in the sum of \$15,000 for the faithful performance of the member's duties, and the agency may also require any of its subordinates to give bond, the premiums upon the bonds to be paid by the agency."

At the request of the Chair of your Committee, the Department of the Corporation Counsel transmitted a revised proposed bill, approved as to form and legality, incorporating nonsubstantive revisions.

Your Committee recognized the importance of compliance with State law and, therefore, recommended passage of the revised proposed bill.

Your Committee voted 9-0 to recommend passage of the revised proposed bill on first reading and filing of the communication. Committee



A BILL FOR AN ORDINANCE AMENDING CHAPTER 2.44,
MAUI COUNTY CODE, RELATING TO BOND COVERAGE FOR MEMBERS
AND SUBORDINATES OF THE MAUI REDEVELOPMENT AGENCY

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:


SECTION 1. Chapter 2.44, Maui County Code, is amended by adding a
new section to be appropriately designated and to read as follows:

**"2.44.040 Maui redevelopment agency bond coverage. The
director of finance shall procure a bond for the members of the Maui
redevelopment agency and, if required by the agency, its
subordinates, to satisfy the requirements of section 53-2, Hawaii
Revised Statutes."**

SECTION 2. New material is underscored. In printing this bill, the County
Clerk need not include the underscoring.

SECTION 3. This ordinance shall take effect upon its approval.
