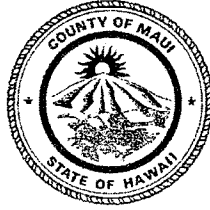

**SUBJECT: PROHIBITING COMMERCIAL OCEAN RECREATIONAL ACTIVITY AT HANAKAO'O BEACH PARK (EACP-27)**

In response to your letter dated June 6, 2019 regarding current holders of Commercial Ocean Recreational Activity ("CORA") permits for Hanakao'o Beach Park and whether current holders of CORA permits for Hanakao'o Beach Park also have CORA permits for other locations, we have reviewed the individual records and have found the following information for FY 2019, with permits expiring June 30, 2019:

- Two (2) companies have a single CORA permit at Hanakao'o Park.
  1. Extended Horizons Inc.; and,
  2. Lahaina Divers Inc.
- One (1) company has CORA permits for Hanakao'o and D.T. Fleming Parks.
  1. Maui Kayak Inc.
- One (1) company has CORA permits for Hanakao'o and Kamehameha Iki Parks, as well as Ulua-Mokapu Beach Park.
