A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2025  
BUDGET FOR THE COUNTY OF MAUI, ESTIMATED REVENUES;  
OFFICE OF THE MAYOR, ECONOMIC DEVELOPMENT  
PROGRAM, GRANTS AND DISBURSEMENTS FOR BUSINESS DEVELOPMENT  
AND TECHNOLOGY; MAUI FAIR

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5657, Bill No. 60, CD1, FD2 (2024), as amended, "Fiscal Year 2025 Budget", Section 2, Estimated Revenues, is amended to increase Carryover/Savings, General Fund, in the amount of \$1,500,000, and increase the total accordingly, to read as follows:
