RELATING TO THE APPOINTMENT OF BRANDIS SARICH TO THE URBAN DESIGN REVIEW BOARD


WHEREAS, by correspondence dated July 24, 2017, Mayor Alan M. Arakawa notified the Council that he nominated Brandis Sarich to the Urban Design Review Board for a term expiring March 31, 2020, to fill a vacancy replacing Demetreos Callinicos, pursuant to Sections 2.26.030 and 2.40.100, Maui County Code (“MCC”), and Section 13-2, Revised Charter of the County of Maui (1983), as amended, (“Charter”); and

WHEREAS, Section 13-2, Charter, requires the Mayor’s nominee to be approved by the Council; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:
