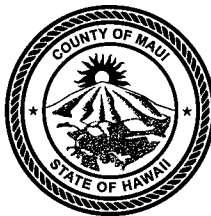

(15) consecutive days for this event between October 31, 2016 and November 14, 2016; and

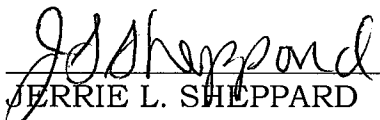
WHEREAS, the Organizers have duly applied for a use permit with the Department of Parks and Recreation for the 2016 Aloha Classic; and
