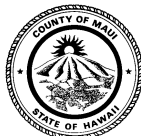

May I please request your response to the following:

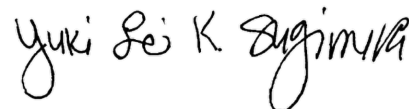
1. Provide the Launiupoko and Olowalu water system analyses prepared by Carollo Engineers, Inc. For each system, please summarize:

 - b. Assets that have exceeded their useful lives or are expected to require replacement within two years, including the estimated replacement cost and timing for each asset.
 - c. Each potable system's compliance with State Department of Health drinking water requirements, including any outstanding notices of violation, corrective-action requirements, or consent agreements.
