Response: When a reimbursement is received for qualified expenses, it is recognized as grant funding in Appendix A, Part I as FEMA reimbursements are considered grant funds for reporting purposes. When FEMA obligates the funding, the expenditures that are covered by the reimbursement will be reclassed from the original accounts (Emergency Fund, Highway Fund, etc.) to the grant fund.

Response: The reimbursement is recognized in the Fiscal Year in which it is received.
