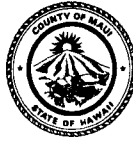

Response: Funding for salary increases was included in the FY 2026 Budget under Countywide Costs - Fringe Benefits. Although the Administration initially anticipated the Salary Commission might go with a lower percentile, sufficient funding is available and no cuts are needed due to the approved increases.
