BILL NO. 13, CD1 (2023)

A BILL FOR AN ORDINANCE RENAMING PUAMANA BEACH PARK IN  
LĀHAINĀ TO PUAMANA CULTURAL PRESERVE AT WAIANU‘UKOLE

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Chapter 12.40, Maui County Code, is amended by adding a  
new section to read as follows:

**“12.40.310 Puamana Cultural Preserve at Waianu‘ukole.**  
**Puamana Cultural Preserve at Waianu‘ukole refers to the area**  
**formerly known as Puamana Beach Park, identified as tax map key**  
**(2) 4-6-033:001, and located on Honoapi‘ilani Highway, Lāhainā,**  
**Hawai‘i.”**

SECTION 2. New material is underscored. In printing this bill, the  
County Clerk need not include the underscoring.

SECTION 3. This Ordinance takes effect on approval.


