THE COUNCIL PUBLIC HEARING THAT HAD BEEN PLANNED WITH THIS SPECIAL COUNCIL MEETING HAS BEEN CANCELED FOR THE 9:00 A.M. A QUORUM IS PRESENT TO CONDUCT THE BUSINESS OF THE COUNCIL.\r\n\r\nFOR THE RECORD, I'M THE DEPUTY COUNTY CLERK RICHELLE THOMSON AND WITH ME IS LEGISLATIVE DIVISION STAFF JOYCE MURASHIGE, DELL YOSHIDA AND ARTHUR SUYAMA. MACKOU. WE CANNOT -- >> THAT ONE IS OUT GO TO NEXT ONE. >> ANY OTHERS THAT HAVE BEEN DISREGARDED? >> WE HAVE ALL THE ITEMS LISTED ON SECOND AND FINAL READINGS, THOSE BILLS.\r\n\r\nBILL 162, 173, 174, 175. >> I BELIEVE WE WON 670 I DON'T KNOW WHY WE'RE ADDRESSING THIS AND TO GIVE THE WATER -- LIKE THEY ARE PLANNING WITH HAWAIIAN HOMES. CAN YOU GO ON TO NEXT ONE? >> SURE. COUNCIL MEMBER PALTIN, TRANSMITTING A PROPOSED AMEND TO BILL 172. >> WE'RE NOT PICKING UP BILL 172. WE'RE NOT TAKING THAT UP. >> SO THERE ARE MORE? >> FIRST ONE? NO?\r\n\r\nSECOND ONE? HOW ABOUT THE THIRD ONE? >> WHAT IS THAT? >> THE THIRD ONE IS WITH JOHNSON. >> YOU ARE TALKING ABOUT -- >> WHEN IT COMES TO MAKAWAO. >> THE AMENDMENT? >> MAKAWAO IS CONDUCTED UNDER MY GREAT-GRANDMOTHER AND MY GRANDFATHER KING KU LIKE AND I BELIEVE I SPOKE WITH HALE'AKALA RANCH AND EMI AND THEY WERE WONDERING WHAT THE BLOWING UP OF THE WATER DITCHES IS AND WHO CAME UP WITH THE PICTURE IDEA THAT MAUI PONO WILL OWN OUR DITCHES NEXT ITEM.\r\n\r\n>> NEXT ITEM, BILL 176, HOW ABOUT THAT? CAN WE GO FOR THAT? >> YES. >> ALL RIGHT, ORDINANCE AMENDING RELATING TO THE ISSUANCE OF GENERAL OBLIGATION BONDS OF THE COUNTY OF MAUI ISSUANCE, SALE AND DELIVERY OF SAID BONDS, DEPARTMENT OF ENVIRONMENTAL MANAGEMENT. DUE TO THE FACT OF THE ENVIRONMENTAL MANAGEMENT YOU HAVE BEEN DEFAULT IN ANY AND EVERY WAY. THESE BONDS ARE SECURED FOR 350,000 MILLION SHARES OF STOCK WITH A DOLLAR VALUE OF \$20 MILLION. WHICH THE DOLLAR VALUE WENT UP WITH 10% INTEREST RATE SINCE 1914. I DON'T KNOW, BUT THE BONDS ARE SECURED ONLY THROUGH THE CROWN. YOU GUYS ARE BEING ALLOWED TO USE ASSETS AND BONDS, AND TRANSFERRING THEM INTO YOUR DIGITAL CURRENCY.\r\n\r\nLITTLE TO NO HELP FOR OUR PEOPLE. NOW I WOULD HATE TO HAVE ALL OF THESE BONDS OR STOCKS STRIPPED FROM YOUR HANDS. YUKI LEI'S BROTHER WAS ONE WITH VERY, VERY HUGE COMPANY THAT WAS PART OF THE BONDS, AND STAKEHOLDERS' SHARES. I'M THE SOLE HEIR OF BLACK ROCK, ORACLE, JOHN

DEERE -- [SPEAKER NOT UNDERSTOOD] THE AMOUNT OF HELP FOR THE WORLD IS DISGUSTING AND THEY ARE USING THESE BONDS TO CREATE WAR IN ISRAEL, IN EVERYWHERE AROUND THE WORLD. FOR THE FIRST TIME EVER THE ENTIRE JAPAN INCLUDING JUDICIAL SYSTEM HAS STOOD UP AN INTERNATIONAL COURT SAYING NO MORE WAR. NOW IF THESE BONDS ARE GOING TO BE SECURED UNDER ENVIRONMENTAL MANAGEMENT, NEARLY ALL OF YOU WERE THERE LAST RUN AND YOU DISREGARDED MY REPORT THROUGH ARCHAEOLOGIST THAT YOU HIRED. IT'S A STATE CULTURAL AND HISTORICAL ASSESSMENT FINDER FOR THE WATER WELLS OF LANA'I POKO AND IT WAS NOT BAD SHIT CRAZY ASSUMPTION OR MAGIC, IT WAS SCIENTIFICALLY PROVEN, TRANSPARENT AWESOME REPORT.\r\n\r\nI DID THE JOB THAT YOU GUYS DID NOT AND IN THIS REPORT AND IN THE VIDEO WITH THE SITE VISIT, THEY HAD TO ASK ME TO GO, BECAUSE I'M THE GRANDDAUGHTER, THE ROYAL HISTORICAL DOMAIN OF 1810, OF WEST MAUI AND MY REPORT SHOULD HAVE BEEN MORE RESPECTED AND I WAS CRYING AT TAKING TO YOUR APPOINTED 'AINA ARCHAEOLOGY, IF YOU DISREGARD MY REPORT YOU ARE ALL GOING TO BURN. >> CAN WE MOVE ON TO THE NEXT ONE THAT YOU HAVE? >> WELL, SO THEN YOU CAN SEE WHY I'M A LITTLE BIT HESITANT AND EVEN ALLOWING ANY MORE BONDS INTO THE ENVIRONMENTAL MANAGEMENT OF YOUR SAME TEAM. SO I'M HOPING THAT YOU DON'T LET ME DOWN, BECAUSE AT THIS POINT, I WOULD LIKE TO FIND AND FOUND WITH MR. SCHMITT, INTERNATIONAL PARTNERSHIPS COMING IN AND TELLING ME KAMALEI, WHY DO YOU WORK WITH PEOPLE THAT JUST CALL YOU CRAZY AND DISREGARD? >> YOU HAVE REACHED OVER THREE MINUTES. >> KALAMAI.\r\n\r\n>> NEXT ONE. >> A BILL FOR ORDINANCE AMENDING BILL 177, ARE WE A GO? >> YES. >> U.S. ENVIRONMENTAL PROTECTION AGENCY HAS GONE AGAINST THE HEALTH AND WELFARE AND SAFETY OF OUR PEOPLE'S EXHIBIT, WHICH IS THE REASON THAT OUR CONSTITUTION RIGHTS FROM YOUR FATHERS OF AMERICA HAVE GIVEN US, WHEN THEY SEE THAT THE GOVERNMENT OFFICIALS OF THE JUDICIAL COURTS IS CORRUPT AND NOT ACT ACT BEST HEALTH, WELFARE AND SAFETY OF OUR PEOPLE, DUE TO ENVIRONMENTAL IMPACTS THAT DEVASTATE ALL. THAT IS A LITTLE BIT OF A CONCERN. YOU HAVE LET ME DOWNTIME AND TIME AGAIN. IT'S BEEN -- YOU KNOW, U.S. MILITARY.\r\n\r\nWELL, YOU GUYS KEEP ALLOWING THESE PEOPLE, WHO CHOOSE -- [SPEAKER NOT UNDERSTOOD] TO SPEAK ON BEHALF OF THE ENVIRONMENTAL AGENCIES REPRESENTING THE KINGDOM OF HAWAI'I? BECAUSE HE IS A CONFLICT OF INTEREST. HE WORKS FOR UH. NOW I DON'T EVER WANT TO HEAR THEM SPEAKING AGAIN FOR ENVIRONMENTAL IMPACTS BECAUSE THEY ARE SO BAT SHIT CRAZY -- HALE'AKALA, THE MOUNTAIN OF THE OF THE SUN, THERE'S FOUR PLUMES WITH HIGH PEAK ENERGY, BUT HALE'AKALA, ONE PLUM. THIS 752 TOXIC TONS OF LAVA HELL LIQUIFIES IN HEAT [SPEAKER NOT UNDERSTOOD] KIHEI, ALL OF IT. BUT THAT WAS YOUR GUYS' CHOICE AND NOBODY HAS -- YOU KNOW, EVEN TRIED TO LISTEN TO ME? WE COULD HAVE PREVENTED THAT ONE, TOO. SO AGAIN, YOU GUY HAVE LET ME DOWN ON BILL 177. I'M DISGUSTED THE DISREGARD AND I'M HOPING THIS TIME YOU GUYS LISTEN TO ME, BECAUSE THE PILOT PROGRAM THAT WENT THROUGH AA SYSTEM IS 100% AND I HAVE A WAY TO CLEAN IT UP.\r\n\r\nBECAUSE I'M A RECOVERING ADDICT AND APPARENTLY BAT SHIT CRAZY TO YOU GUYS I WOULD LIKE TO BE HIRED AS A CULTURAL AND IMPLY THAT YOU GUYS INCLUDE CULTURAL. AND ALL OF HAWAIIAN CULTURAL INTO THE ENVIRONMENTAL METHODS OF HAWAI'I. I'M NOT TALKING COMMERCIALIZED SUBSTANCE OF SELF-APPOINTED HAWAIIANS. I'M TALKING REAL PICKERS, REAL KALO FARMERS, YOU KNOW, REAL CULTURE OF THE MOST OF THE PEOPLE OF CULTURE OF HAWAIIAN AREN'T HAWAIIAN AND THEY ARE COMMERCIALIZED SUBSTANCE -- I DON'T KNOW WHAT CULTURE THAT IS, BUT IT'S NOT IN MY PAYO PAYO AND TO INCLUDE CULTURAL AND MYTHICAL BELIEFS OF OUR CULTURE AND THE LAW OF THE LAND. THERE WAS A REASON FOR OUR MAGNETIC FIELDS HOLDING DARKNESS AND WITH GOOD FELLOW OPENING UP THESE THINGS WE NEED TO KNOW WHY THE HAWAIIANS DID WHAT WE DID. WE WERE AMAZING MASONRIES AND CARETAKERS OF THE LAND AND WE COULD ONLY LEARN SO MUCH. AND I'M HOPING THAT YOU GUYS CANNOT DISREGARD THE HAWAIIAN CULTURE ANY LONGER. >> THANK YOU. YOU HAVE ONE MORE BILL 178. >> 178. DUE TO THE WATER DIVISION OF THE U.S. ENVIRONMENTAL PROTECTION AGENCY. SO I HAVE A PRIVATE TEAM WITH LARGEST FEDERAL LAND BANK THAT REALLY WANTS TO HOLD CONDUCT AGAINST THE HEALTH, WELFARE AND SAFETY OF OUR PEOPLE AND STRIP IT OUT OF THE HAND AND HOLD ACCOUNTABLE THESE PEOPLE SEEM VERY CONVINCING, AND I DON'T KNOW WHY I EVEN CONSIDER HAVING FAITH IN ANY OF

YOU, BUT I WOULD LIKE TO WORK WITH WHAT WE GET.\r\n\r\nI WAS CHOSEN TO TERMINATE A BIG FIVE LEASE AND FELL IN LOVE WITH A BALDWIN AND HAVE TO WORK WHAT WE HAVE GOT AND HAVE FAITH THAT PEOPLE WILL COME TO A COMMON GOAL AND SEE US AS ONE VA'A. NOBODY IS BIGGER OR BETTER THAN THE OTHER. WE'RE ONE CANOE AND THE HOPE OF THE NUCLEOLUS, SURROUNDED BY WATER MEMBRANE, THE PACIFIC OCEAN AND EACH IS AN ORGAN OF THE WHOLE BODY AND IF ONE NATION IS DOWN, WE'RE ALL DOWN, WE'RE ONE VA'A AND WE SHOULD ALL BE AND I DON'T WANT TO EVER HEAR THE SELF-APPOINTED PEOPLE SPEAKING FOR THE CULTURE. ON JULY 15, 2023, I AM SCREAMING AND CRYING, AND JUST LOSING IT BECAUSE THESE UNPERMITTED, UNREGULATED AND VERY, VERY ABANDONED CONSIDER AN OPEN FOR ANYBODY TO CLAIM OWNERSHIP OF WHICH YOU GUYS LOSE BIG MONEY IF I GO AND APPOINT SOMEBODY ON THAT LAND, AND CUT YOUR EASEMENTS OFF. I'M NOT HOLDING TO BE A PROBLEM. I'M HOPING THAT YOU WILL NO LONGER DISREGARD ME. I'M THE OWNER OF THE WETTEST SPOT IN THE WORLD, THE LARGEST WATERSHED IN THE STATE OF HAWAI'I. AND LEASE HOLDER TO HANALEI.\r\n\r\nHAVE I GONE TO MONEY AND HAVE EVER, EVER HELD YOU ACCOUNTABLE OR PROBLEMS? I TURNED CHEEK FROM THINGS THAT I KNOW COULD HAVE KILLED YOUR RESPECT, AND REPUTABLE, YOU KNOW STANCE. I HAVE FAITH IN THOSE WHO CAUSE ME HARM, BUT WATER IS GOING TO AFFECT OUR FUTURE GENERATIONS, WATER HAS LIFE AND INSIDE WEST MAUI, THERE WAS A PARTICLE OF CONTENT BRUSHED WITH HIGH PRESSURE WITH HIGH PEAK OF LAVA THAT CREATES FUSION. THIS FUSION CAN BE CAPTURED TO OPEN SPACE AND TIME THAT ONLY THE ANCIENT HAWAIIANS KNOW. U.S. ENVIRONMENTAL PROTECTION AGENCY OF FEMA IS DIVERTING OF THE INTO NEW ORGANIZATIONS OF DIGITAL CURRENCY. SO I'M KIND OF OVER IT AND THE FEDERAL LAND BANK OF MAUI AGRICULTURE IS WHAT COUNTS. WE ARE NOT NEEDING MONEY ANY MORE.\r\n\r\nIT'S A DEVALUED NOTE. WHAT VALUE IS THE HEALTH AND WELFARE AND THE SAFETY AND PROTECTION OF OUR FUTURE GENERATIONS. HOW CAN WE BE BETTER ANCESTORS? I ONLY HONOR HIM AND WISH THE COUNTY COULD HAVE GIVEN HIM A CHANCE BECAUSE HE COULD HAVE TAUGHT US MANY THINGS. WHEN IT COMES IT LETTING MY KU HUNA DOWN, MR. LIKE TIE AND I UNDERSTAND WHY YOU HAVE DISREGARDED ME BECAUSE I RANT AND RAVE LIKE A CRAZY PERSON. CAN YOU IMAGINE, I KNEW THAT WE WERE GOING TO BURN -- I THOUGHT IT WAS GOING TO BE A LOT WORSE -- >> THREE MINUTES.\r\n\r\n>> CAN YOU CONCLUDE, PLEASE? >> WHEN IT COMES TO WATER, THE WATER IS A HUGE MACHINE. WE WEREN'T JUST WITH MAGNETIC FIELDS OF LAVA AND WATER. WATER HOLDS ENERGY AND I'M THE GRANDDAUGHTER -- THE OLDEST AND MOST POWERFUL GOD OF HAWAI'I AND GUARDIAN OF THE SPRINGS AND BLESSED WITH THE KNOWLEDGE OF OLD, ON RESONATED THROUGH RIGHTEOUSNESS -- I REALLY, REALLY WOULD LIKE TO ENCOURAGE THAT YOU GUYS TAKE HEED TO OUR CULTURE. THE MISMANAGEMENT, THE DISREGARD AND THE ENVIRONMENTAL IMPACTS LATELY OF RED HILL, HALE'AKALA, 'OL WAI AND OUR PEOPLE, OUR CHILDREN, MY MENTAL HEALTH, MY SPIRIT, MY CHILD, IT'S -- IT'S SCARY. NO HOUSING, NO FOOD. WE HAVE THREE DAYS OF FOOD.\r\n\r\nTHE KINGS AND QUEENS DID NOT KEEP THE PROFITS TO MAINTAIN THE WATER DITCHES AND WATERSHED, BUT GAVE IT TO THE KANAKA MAOLI FOR REPLENISH OF OUR CORAL REEFS GIVING MORE OXYGEN THAN THE TREES ALONE. >> THANK YOU. THANK YOU. >> BECAUSE OF THE WASTE MANAGEMENT PROBLEMS OF INJECTION WELLS, WE HAVE A SERIOUS PROBLEM. OUR ATMOSPHERE IS FALLING AND THE SUN'S HEAT IS COMING CLOSER TO THE SURFACE. WE'RE BURNING FROM ABOVE AND BELOW. THIS IS SOMETHING WE ALL HAVE A COMMON GOAL WITH.\r\n\r\n>> THANK YOU SO MUCH. WE APPRECIATE YOU SHARING ALL OF THOSE IDEAS WITH US. THANK YOU VERY MUCH. >> SO THE DECORUM, I WOULD LIKE TO INCLUDE THAT WE NEED TO ADJUST IT TO FIVE MINUTES. WHEN IT COMES -- >> CHAIR, DID YOU WANT ME TO CALL THE NEXT TESTIFIER? >> SHE IS FINISHED. >> I'M THE OWNER OF THE WATER.\r\n\r\nI'M A LANDOWNER. I'M THE EASEMENT HOLDER AND EVERY DEPARTMENT BECAUSE I'M ALLOWING IT TO BE THROUGH YOU GUYS. >> THANK YOU SO MUCH. WE HAVE TO CALL ON OTHER PEOPLE. >> NOT YOU, AUNTIE, YOU TRIED TO HELP ME WITH A HOME. OUT OF ALL OF THESE PEOPLE. YOU TRIED TO HELP ME WITH A HOME. YOU TOOK YOUR TIME AND RESPECTED ME.\r\n\r\nSO I WANT TO ASK, PLEASE, I HAVE A BEAUTIFUL PILOT PROGRAM THAT WAS JUST APPROVED THROUGH THE AI THAT WILL CLEAN HALE'AKALA AND THE FOR YOU TO REPRESENT THE MOST BEAUTIFUL OF ENGINEERING --[SPEAKER NOT UNDERSTOOD] WHAT IT COMES TO THE ABANDONED WATER WELLS IT WOULD

ONLY BE A BENEFIT TO WORK WITH ME AND NOT DISREGARD ME ANY MORE. >> WE WILL NOT DISREGARD YOU. THANK YOU VERY MUCH. >> CHAIR, THE NEXT TESTIFIER IS NICKELL ANANDA AND PLEASE LET US KNOW WHAT ITEM YOU ARE TESTIFYING ON. >> NICKELO ANADA, YOU CAN UNMUTE ON YOUR END. >> NICKELO ANANDA AND I BELIEVE THE ITEMS I WAS GOING TO TESTIFY ON HAVE BEEN REMOVED FROM THE AGENDA. >> THANK YOU FOR LETTING US KNOW.\r\n\r\n>> CHAIR, AT THIS TIME THERE'S NO ONE LEFT TO TESTIFY, SO I WILL GO AHEAD AND GIVE LAST CALL FOR TESTIMONY AT THE BEGINNING OF THE MEETING.
