### STOP SIGN ON HAIKU ROAD (HAIKU) (IT-35)

**Description:** The Committee is in receipt of the following:

1. County Communication 20-318, from Councilmember Michael J. Molina, referring the matter relating to the installation of a stop sign on Haiku Road in Haiku.
2. Correspondence dated September 28, 2020, from Councilmember Michael J. Molina, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 10.44.030, MAUI COUNTY CODE, RELATING TO STOP REQUIRED-THROUGH STREET INTERSECTING THROUGH STREET." The purpose of the proposed bill is to add a stop sign at the intersection of Haiku Road where it transitions to Kokomo Road moving in a southerly direction toward Makawao near the Haiku Cannery Shopping Center.

**Status:** The Committee may receive an update from the Department of Public Works and discuss related matters. The Committee may also consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider the filing of County Communication 20-318 and other related action.
